Investigation Complaint

Re: Murder Cover up of Stock Investor, Ms. Ada Lee Mays Jones by corrupt government Official's from the Northern District of Alabama who covered her up murder and protected a Stock Swindle scheme that exceeded 35 Million dollars in Stock as the evidence attached will reveal.

SUBJECT: The Murder, and the murder cover up of my Aunt, Ms. Ada Mays Jones who was murdered in a so called elaborate scheme to embezzle her estate by my family members, including the Trustee of my Aunt's Last Will and Testament attorney, Mary Lee Abele and Jefferson County Probate Judge Orris H. Florence (Birmingham, Alabama).

The devious plan to fatally poison my Aunt, Ms. Ada Mays Jones and make it appear that she died of natural causes which subsequently and immediately backfired on the willing participant's involved in the scheme to kill a major stock investor who had stock investment worth over 35 million dollars invested into Stockham and Valve Pipe and Fitting's, Inc., located in Birmingham, Alabama.

The Stockham Corporation in 1998 was purchased by Crane Valve of North America group. After the evil plan to murder my Aunt, Ms. Ada Mays Jones backfired, the Trustee of the "Final Will" of Ms. Ada Mays Jones, would use her husband criminal attorney, William (Bill) Dawson to use his connections at the local U.S. Attorney's office for the Northern District of Alabama in Birmingham to intercede on the State of Alabama murder investigation of the richest African-American woman in the State of Alabama.

The corrupt bribe taking Asst. U.S. Attorney's Robert P. McGregor and his supervisor, Asst. U.S. Attorney Billy Lee Barnett would take a suborn from the Trustee of Ms. Ada Mays Jones "last will and testament".

The dirty government attorney's would be given a proposition to use their police powers to clean up the botched murder scheme so that my Aunt Gwendolyn Davis who lived with Ms. Ada Mays Jones wouldn't be charged with her aunts murder.

The willing participants knew that once Ms. Gwendolyn Davis would spill the beans while in custody if she was charged with her aunts murder, the dirty scheme to fatally poison Ms. Ada Mays Jones with an overdose of heart medication and cocaine to make it appear that she died from a natural causes backfired because of the flimsy story that Gwendolyn Davis had given to Jefferson County Coroner, Jack Parker that she had approximately 30 minutes earlier given her aunt medicine. Coroner Jack Parker knew that Ms. Ada Mays Jones had been dead for at least 36 hours from the rigormortis that had set up in her body.

Deputy coroner Jack Parker would order an immediate investigation into the murder of Ms. Ada Mays Jones after the autopsy report and Toxicologists report for Ms. Ada Mays Jones revealed that she had an overdose of powerful heart medication and cocaine that was mixed into Chinese food, cocaine showed up in her blood stream, Ms. Ada Mays Jones was 69 years old.

CONCLUSION

This correspondence to you, Ms. Mary Schapiro, Chairman For the Securities Exchange Commission who swore at your confirmation that the Security and Exchange Commission would now under your authority would have more transparency and vigorously investigate all complaints and would bring Justice to investors who had been wronged by corruption and fraud and that you didn't care who committed the crime, you will bring charges.

This is why I reach out to you Ms. Schapiro for Justice from my family, I need your office not to protect corruption because dirty U.S. Justice Department Official's stoop so low that they conspired to cover up a citizen's heinous murder so that they could benefit financially from a fraudulent stock swindle as the evidence attached hereto will reveal.

My aunt, Ms. Ada Mays Jones was the wealthiest Stock Investor in the State of Alabama at the time of her heinous murder scheme when she was poisoned at the age of 69 years young by a mixture of cocaine and heart medication, which induced a heart attack on my unsuspected Aunt.

My Aunt a leader in the community and powerful structure in the church community . She never used drugs and never had no heart problems or any sickness. What makes this stock theft crime so heinous by the Criminal Enterprise out of Birmingham, Alabama under the color of law, is that dirty Asst. U.S. Attorney's and dirty F.B.I. agent's has conspired with my aunt's murders so they could benefit financially from the stock investment that my Great Grandmother invested into the Stockham Corporation.

The Criminal Enterprise thought they had gotten away with the perfect crime by using their police powers to get the medical examiner, Gary T. Simmons to take a bribe and falsify my aunt's case summary to justify him covering up her murder.

By the Criminal enterprise covering up the murder, they could be partner's for a percentage of the stock's Investment into the Stockham Corporation Stock portfolio that exceeded \$35 million dollars November 1988, it's an ongoing crime of Fraud. The dirty corrupt government official's agreed collectively to share my aunt's wealth and hide her last will and testament from record at the Jefferson County Probate Court in Birmingham, Alabama which became the motive for her murder.

The intervention of the corrupt government official's were part of the scheme to put a lid on the fact my aunt was murdered for her stocks, if it was called a murder, it would have been a massive and exposed investigation, which is something that they didn't want.

There dirty scheme was to suppress and conceal the fact that she was murdered so they could enjoy the estate, along with my family members who executed the murder.

My aunt was murdered for the pleasures of her stock wealth that she inherited from her mother, Ms. Anna Wilson Harrell, who invested into Stocks and Securities in Stockham Valve Pipe and Fittings, INc., presently known today as Crane Valve of North America.

I have supplied in the exhibits section to your office massive evidence and court filed documents under the penalty of perjury and also two Birmingham Times News paper Editorial Story which reveals the corrupt official's names publically, they all declined to comment or clear their names due to their guilt, or bring slander charges against me and the Birmingham Times.

The corrupt officials framed me once they found out that Jefferson County Deputy Probate Judge Edward Vines whose brother is my accountant, Gerald Lee Vines (205 - 592-3619).

Mr. Gerald Vines has a copy of my Aunt's "Last Will and Testament", which reveals the Stock Records and other assets., Mr. Gerald L. Vines life has been threatened by Asst. U.S. Attorney Billy Lee Barnett who is nothing more than a punk and coward and Mr. Vines told me about the \$28 million dollars due to my family.

ASUA Barnett would send dirty drug F.B.I. agent Jeffery L. Burgess and two more agents by Gerald Vines office, they would threaten Mr. Vines with guns if he expose Barnett freezing the Stocks and Bank accounts belonging to Ms. Ada Mays Jones estate. Barnett is the mastermind behind covering up Ms. Jones murder so he could loot her estate.

I am presently being held in prison on a manufactured, therefore fraudulent indictment scheme, conducted by ASUA Robert P. McGregor who forged the Grand Jury foreman's signature, Mr. Terrell Brett Clement would sign a Notarized sworn affidavit that his signature was in fact, forged on my indictment by someone. His signature from another defendant indictment which bares AUSA Robert P. McGregor as the government attorney, my sentencing judge C. Lynwood Smith, Jr. would recuse himself on September 11, 2007 after the fraudulent indictment scheme was exposed, he gave no reason for recusing himself from anymore participation in my case.

There is also more evidence to support this fact. A request to the United States Executive Attorney in Washington, D.C. where all United States Attorney's Office records are stored, the Honorable Asst. Director, Ms. Marie A. O'Rourke would reveal in an response to me that there are no records of any Mr. Terrell Clement signed any indictment against me on September 26, 2001 request number; [03-3921] Freedom of Information Privacy Act Unit.

These are corrupt official's who thinks they are above the laws of the constitution and can bribe any government official with my aunt's blood money who attempt's to bring them to Justice.

Ms. Schapiro, can I expeditiously get an Investigation request no. so that you can get the last will and testament of my aunt Ms. Ada Mays Jones. I know that if you choose to bring Justice to this miscarriage of Justice by corrupt racist who think that they can hide behind their Justice Department positions and never be brought to Justice for evil.

You have my Great Grand Mother Anna Wilson Harrell State of Alabama death certificate attached hereto as Exhibit (BI & B II) which reveals their social security numbers and birthdates.

Your organization that you heads have the records and the dirty culprits involved in the heinous crime must be brought to justice.

In the past pertaining to Investigation Request No: ADO-937437, August 21, 2003. Mr. Timothy J. Barker, Chief branch of Broker - Dealer and Transfer agent Examination conducted an investigation, the individuals involved with the stock swindle of Ms. Ada Mays Jones assets was secretly blaming the crime on eachother.

The Bush administration covered up the crime and halted the investigation because of Congressman Spencer T. Bachus III's involvement in the theft of the stocks. Bachus law partner, my ex-attorney Randy Allen Dempsey who has been using a fraudulent Power of Attorney for years on deceiving my wife and myself out of our inheritance.

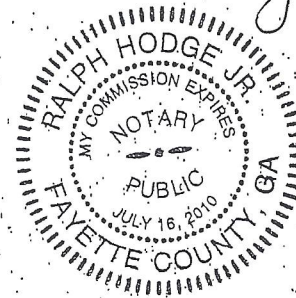



Ms. Anna Wilson Harrell would bequeath her 35 million dollar stock assets investments in the Stockham Corporation portfolio to her only surviving child, Ms. Ada Mays Jones who would be murdered approximately 3½ years later for her stock investments in Stockham Corporation portfolio, which is presently in the hands of fraudulent attorney's using a fraudulent Power of Attorney to deceive the true heirs and the Security Exchange Commission and I.R.S.
