**RE:** The Murder and Murder Cover-up of Mrs. Ada Lee Mays Jones, a rich African-American heiress who was murdered for her estate that exceeded (\$40,000,000.00) forty-million dollars as evidence will reveal, the stolen money from the estate of Mrs. Ada Lee Mays Jones has been embezzled by corrupt federal prosecutors from Birmingham, Alabama. Their names are Mr. Billy Lee Barnett and Robert P. McGregor Jr., included in the murder cover-up and embezzling scheme are F.B.I. agent Jeffery L. Burgess, Congressman Spencer T. Bachus III. and his nefarious mind law partner, Randy Allen Dempsey Jr.; The crime committed by these corrupt officials is beyond imagination as they have used their police powers in their district, Northern Alabama, to conceal Mrs. Jones (from here-on) heinous murder conspiracy and they gave her murder conspirators a pass for murder and after this misconduct they started embezzling her estate that exceeded (\$40,000,000.00) with her murder conspirators which became the motive for her murder.

Dear Attorney General Eric Holder Jr.,

This is the second correspondence to your office from concerned citizens for justice for Mr. William Anthony Fagnes (from here-on Mr. Fagnes) and Mrs. Ada Lee Mays Jones who both have been wronged by abuse of power from the corrupt officials misconduct which the Justice Department is aiding and abetting the corrupt officials from Birmingham, Alabama who never needs a pass for their evil conduct as they need to be brought to justice for all the evil and misery they've applied to Mr. Fagnes' life as they have embezzled 28 million dollars away from Mr. Fagnes and his wife, Iris; who have only a few months to live

as she became a multi-millionaire from stocks and money due to her from the estate of Mrs. Ada Lee Mays Jones, her aunt, who was fatally poisoned in a so-called elaborate murder scheme to make it appear that she died of natural causes, which subsequently backfired on the willing participants to hide Mrs. Ada Lee Mays Jones assets from record at the Jefferson County Probate Court.

Attorney General Eric Holder Jr., as we turn to you for the last time Mr. Fagnes' exhibits and evidence that reveals one of the most heinous crimes in American history; we hope and respectfully request to The Executive Secretariate to personally make you aware of Mr. Fagnes situation.

The corrupt officials including attorneys and stock brokers, etc.; was blaming the securities fraud on each other in year 2004 to the investigators from the Atlanta field office of the Security and Exchange Commission (attached hereto) as Exhibit 2, file number ADO-937437) that was conducted by Mr. Timothy J. Barker (Chief Branch of Broker Dealer and Transfer Agent Examiner) and the Justice Department was also involved in the investigation of corruption.

As Mr. Barker conducted the investigation it became messy because of the securities fraud and conspiracy murder. You had corrupt Assistant U.S. Attorneys' Billy Lee Barnett and Robert P. McGregor Jr. employed at the U.S. Attorney's Office for the Northern District of Alabama. Corrupt F.B.I. agent Jeffery L. Burgess and more dirty F.B.I. agents from the Regional (6) Drug Task Force in Birmingham, Alabama. The securities fraud and conspiracy included also Congressman Spencer T. Bachus III. and his law partner Randy A. Dempsey Jr. and persons known and unknown they were all pointing fingers at each other for leniency ; was in possession of stolen stocks and bonds belonging to the estate

of Mrs. Ada Lee Mays Jones, who had been murdered in a so-called murder scheme to hide her "last will and testament" from record at the Jefferson County Probate Court in Birmingham, Alabama as evidence will reveal attached hereto. The Justice Department was about to indict Assistant U.S. Attorney Billy Lee Barnett and Assistant U.S. Attorney Robert P. McGregor, F.B.I. Agent Jeffery L. Burgess, Attorney Randy Allen Dempsey Jr., Congressman Spencer T. Bachus III., Attorney Mary Lee Abele, bankers, and persons known and unknown that was involved in the major theft where 40 plus million dollars was being embezzled by the culprits belonging to the estate of Mrs. Ada Lee Mays Jones, that she had bequeathed from her mother, Mrs. Anna Wilson Harrell, a longtime employee of the Stockham Corporation.

Mrs. Anna Wilson Harrell, a major stockholder had made investments and received stock bonuses from the Stockham Corporation for her hardwork as supervisor over the Coremaker Department at the Birmingham, Alabama location as the Stockham Valve Pipe and Fittings Inc. would spread globally during the steel mill heyday and become the world largest valve company.

The Justice Department was about to bring charges against the corrupt officials for securities fraud of having stolen stock belonging to a murder victim estate. The investigation came to a sudden halt because of the embarrassment to the Justice Department and Republican party as ex-President George W. Bush was in a heated presidential race in 2004 against Senator John Kerry and even today if the public became aware that a murder cover-up with government attorneys and F.B.I. agents it would be a media frenzy.

Republican Congressman Spencer T. Bachus III. chairs the Banking and Finance committee for the "GOP" and for it to be revealed that he has been involved in a heinous murder conspiracy and murder cover-up and embezzling scheme of a rich African-American heiress where he had obtained as an attorney stolen money and stocks from the murder victim estate; it will be very embarrassing. Congressman Bachus law partner, Randy Dempsey had used an extortion scheme to take control of Mrs. Ada Mays Jones estate where Mr. Fagnes and his wife was being swindled out of 28 million dollars due to them from Mrs. Jones' estate that was taken from them by a abuse of power by the corrupt officials; Mr. Barnett, Mr. McGregor, and Mr. Burgess.

The corrupt officials has already in 2004 given depositions blaming the embezzling crime of Mrs. Jones' estate on each other as the investigation got messy from the S.E.C.

Attorney General Eric Holder Jr., the (1000) concerned citizens for justice has been recently denied an investigation for Mr. Fagnes by a Ms. Michelle Tapken, who sent back a response stating erroneous that the Office of the Inspector General's Office and F.B.I. had already conducted an investigation into Mr. Fagnes' allegations, which is a lie. See: Attached hereto is Exhibit 5 & 6, which reveals that both office(s) has never conducted any investigation into Mr. Fagnes truthful allegations.

The F.B.I. investigators in 2008 would immediately learn from Mr. Fagnes accountant, CPA Gerald L. Vines that his life had been threatened by 3 to 4 F.B.I. agents, who came to his office brandishing machine guns after Mr. Vines wrote Assistant U.S. Attorney Billy Lee Barnett to release Mr. Fagnes and his wife 28 million dollars due to them from the estate of Mrs. Jones. CPA Gerald L. Vines brother is Jefferson County Probate Judge Edward Vines, who gave his brother Mrs. Ada Lee Mays Jones "last will and testament," which revealed assets over 45 million dollars depending on the fluctation of the stock market; that belong to Mrs. Jones stock portfolio that was invested with the Stockham Corporation. Instead of a response from corrupt Assistant U.S. Attorney Billy Lee Barnett, who is nothing but a common thief; Mr. Vines life is threatened and menaced by the dirty F.B.I. agents who became the muscle for the embezzling scheme.

After the F.B.I. found out immediately with their investigation from Mr. Vines that Mr. Fagnes allegations was the truth; the investigation came to a sudden halt by the F.B.I. who would turn blindeyes to protect their corrupt colleagues misconduct which is obstruction of justice on behalf of the F.B.I. investigators.

The Office of the Inspector General has never conducted an investigation into Mr. Fagnes complaint; they only sent back an erroneous response with no responsible signatures. For Ms. Michelle Tapken to erroneously make the fraudulent response to the concerned citizens for justice for Mr. Fagnes, which appears to be nothing but a petty technicality to not investigate Mr. Fagnes truthful allegations. See: Attached hereto is Exhibits 5 & 6

Mr. Fagnes is also continually being held in false imprisonment by a manufactured, therefore fraudulent indictment arrest by Assistant U.S. Attorney Robert P. McGregor Jr. misconduct as evidence will reveal and Mr. McGregor is in on the embezzlement crime, which he has received at least 3 million dollars of Mrs. Jones' blood money and has never reported a dime to the I.R.S. of the stolen money derived from stolen securities belonging to the estate of Mrs. Jones. Is he above the law because he's a government attorney?

The Executive Office of U.S. Attorney's Freedom of Information/Privacy Act Unit has already revealed that there are no records of any that Mr. Fagnes was ever indicted on September 26, 2001 which means that Mr. Fagnes is continually being kidnapped away from his family by prosecutorial misconduct by Mr. McGregor misconduct as a means to get Mr. Fagnes out of the way so that he would not disturb the embezzling of Mrs. Jones' estate by the corrupt officials misconduct.

In addition to the E.O.U.S.A. FOIA/PA Office admitting to the truth that there are no records at any U.S. Attorney's Office in the United States or the commonwealths that Mr. Fagnes was ever indicted on September 26, 2001 where a Mr. Terrell Clement signed any indictment as being the Grand Jury foreman for the 31 counties that comprises the Northern District of Alabama. Mr. McGregor has Mr. Fagnes illegally being held in prison on a fraud.

On July 11, 2007; Mr. Terrell Clement would sign a sworn affidavit that he heard no evidence against Mr. Fagnes his first day in office on September 26, 2001 as being sworn in as the Grand Jury foreman. Mr. Terrell Clement would admit also that his signature has been forged on Mr. Fagnes indictment by someone. See: Appendix A; Ms. Michelle Tapken has the sworn affidavit.

Honorable Attorney General Eric Holder Jr., as you requested to the American people to bring the evidence of corruption to your office and you don't care who the perpetrators are you will bring justice to the wrongdoings. For some strange and rambling reason Mr. Fagnes has been denied justice repeatably which is bias and prejudice to him by the Justice Department who seems to be taking sides with their corrupt colleagues misconduct who has conspired to conceal a wealthy elderly citizen of the United States murder by using their police powers to give the citizen murder conspirators a pass for murder so that they could benefit from the murder victim estate as they have become multi-millionaires.

For the Justice Department to keep playing games with Mr. Fagnes life by protecting their colleagues and a rogue Congressman is a miscarriage of justice. No one is above the law! As you have repeatably stated Mr. Holder the previous; we are turning over for the last time the complaint that's filed with the newly appointed Unit Chief Robin Ashton for the Professional Misconduct Review Unit as you have just recently appointed him to expeditiously investigate misconduct from corrupt federal prosecutors and employees of the Justice Department and bring swift justice to citizens that had been done wrong by their misconduct.

It's very simple for Unit Chief Robin Ashton to do and that is call CPA Gerald L. Vines at (205) 592-3619 in Birmingham, Alabama and get a copy of Mrs. Ada Lee Mays Jones "final will." Mr. Vines is very paranoid after his life has been threatened by the coward F.B.I. agents, whose the muscle for Mr. Barnett. CPA Gerald Vines is also paranoid because he waited

on your office Attorney General Holder to call his office and get the truth, but Mr. Vines never received one call from your investigators whose aware of Mr. Fagnes situation.

This is a major crime of corruption which there is no statue of limitation for murder and aiding and abetting a murder cover-up and securities fraud. Mrs. Jones "last will and testament" has never been probated and the assets turned over to the true inheritors of her "final will"; it's an ongoing fraud and plus the true fact also Mr. Fagnes is continually being held in false imprisonment by abuse of power as having never been indicted on September 26, 2001 by any federal Grand Jury in the Northern District of Alabama.

Attorney General Eric Holder Jr., we don't know if some one at the Justice Department is behind the cover-up for the corrupt officials misconduct. We don't know if your office has relayed to you that the Concerned Citizens for Justice who signed the (1000) signatures that your office received via certified mail, January 24, 2011. We've been played games with also by Ms. Michelle Tapken, but we will expose to millions of citizens in the United States on the Internet. We will expose Mrs. Jones murder cover-up and about Mr. Fagnes being kidnapped by the government on a fraud indictment scheme.

The Concerned Citizens for Justice do believe that some of the same citizens who stood in long lines, hitchhiked rides, caught buses and trains, walked on foot to the polling places and voted for President Barack H. Obama to become President of the United States, which is one of the greatest countries in the world is built upon bigotry and has been also prejudicial to African-American human rights.

As we prayed for President Barack H. Obama in our churches to lead this country where all citizens would have equal rights as being a citizen of the United States; President Obama appointed you Attorney General Holder to administer justice to all American citizens as you publicly stated that "no one is above the law," and we're calling on you to practice what you preach. That is you will administer justice to all citizen rights.

Your office Attorney General Holder knows that Mr. Fagnes has been wronged by the corrupt officials lust for somebody else money which was wrong for them to conceal a citizen murder and give her murderers a pass for murder and then start looting her estate with the same murderers. Presently today they're multi-millionaires while Mr. Fagnes and his wife have had to suffer because they inherited 28 million dollars that's been embezzled by the corrupt officials greed.

Mr. Fagnes wife, Iris Fagnes, has only a few months to live as she has been diagnosed with pancreatic cancer. The corrupt officials has robbed Mr. Fagnes and his wife Iris; deprived them of their constitutional rights as American citizens pertaining to the 14th Amendment which states: No state shall make or enforce any law which shall abridge the privileges of law. Nor deny an person equal protection of the law, nor deny any person of life, libery, or property without due process of law.

If a citizen is denied his or her constitutional rights, the Fourteenth Amendment gives the citizen a cause of action against the state and the Official: That's what the Concerned Citizens for Justice for Mr. Fagnes want you to do Attorney General Holder, and that is bring justice to Mr. Fagnes and Mrs. Jones as an honorable Attorney General would do and not destroy your reputation for your corrupt colleagues.

The corrupt officials who robbed Mr. Fagnes and his wife is not going to give them a penny for her to have a proper burial which is sad for anyone that inherited 28 million dollars in 1988 worth about 100 million dollars presently, not to be able to have a proper burial.

Do these corrupt officials need protection Attorney General Holder from your office because they're Justice Department employees" If that's the case, its sad on you Attorney General Holder as a honorable official, which means you were right this is a nation of cowards and racist. You can stop your reputation from being exposed that you're in on the cover-up in favor of protecting the corrupt Justice Department officials misconduct.

#### CONCLUSION

For the aforementioned reasons Attorney General Holder we created a Concerned Citizens for Justice movement for Mr. Fagnes and we will not lay down as we prepare to go to the Internet and send millions of e-mails and alerts to residences and businesses in the United States and throughout the world so that they can become aware of Mr. Fagnes situation.

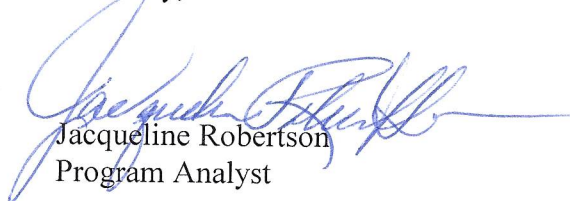
This is in response to copies of documents and materials you submitted to the Department of Justice, which were forwarded to the Office of Professional Responsibility (OPR) for review. The materials relates to your civil case, 1:09-CV-01258-RWS in the Northern District of Georgia.

OPR has jurisdiction to investigate allegations of misconduct involving Department of Justice (DOJ) attorneys that relate to the exercise of their authority to investigate, litigate or provide legal advice, as well as allegations of misconduct against DOJ law enforcement personnel when they are related to allegations of attorney misconduct within the jurisdiction of OPR. It is, however, the policy of this Office to refrain from investigating issues or allegations that could have been or still may be addressed in the course of litigation, unless a court has made a specific finding of misconduct by a DOJ attorney or law enforcement agents or there are present other extraordinary circumstances. Based on our review of the materials you submitted, we have determined that your allegations fall into this category, there is no evidence that the court has made a finding of misconduct, and there are no other extraordinary circumstances present. Accordingly, we concluded that no action by this Office is warranted.

You may wish to seek private counsel or contact the Legal Aid Society to determine what additional legal avenues, if any, may be available to you.

We regret that we can be of no further assistance to you in this matter.
