Harmony Street Baptist Church had already benefited from the "Final Will" of Mrs. Anna Wilson Harrell, the church got copies of bank statements, checking accounts, and a copy of Mrs. Anna Wilson Harrell's "Last Will & Testament" as being a beneficiary of her "Last Will & Testament", there's bank statements and other documental evidence of Mrs.

Located in the left hand corner is the words "Keep this, I knew her well she did hair, she was nice", that's right she was a great dignified classy "nice" woman who was the pillar of the community and a great Christian that never disrespected anyone and was very wealthy and never acted snobbish to no one. She was never weak, but she was caught off guard by the devil in disquise on 11/14/1988 who were her two nieces Gwendolyn Hardy Davis and Iris Elaine Hardy McNabb, they were her brother James Mason Hardy, Sr., Daughters Gwendolyn Hardy Davis and her baby sister Iris Elaine Hardy McNabb, Gwendolyn Davis lived with Mrs. Jones and was angrily being asked to leave Mrs. Jones residence 1124 24th Ave, North Birmingham and to find her somewhere else to live by Mrs. Jones. Gwendolyn had been stealing from Mrs. Jones checking account, one in particular was an account that exceeded \$850,000 (eight hundred and fifty thousand dollars) that was on file with "South Trust Bank" Midfield Branch, a suburb of Birmingham, Alabama. The same Gwendolyn Davis Hardy who at 19 years of age in 1962 would get pregnant by Mrs. Ada Lee Mays Jones (1st) husband William Percy Mays. The family incestous relationship between Gwendolyn and her Uncle Percy Mays would lead to a divorce in 1963 between Mrs. Jones and Percy Mays. Attorney Marcus A. Jones represented Mrs. Ada Lee Mays Jones in the divorce proceedings.

For years on Mrs. Jones who treated Gwendolyn as her daughter would have nothing more to do with Gwendolyn after she found about the incestous relationship she and her husband known as "Percy" to family and friends were having at home.

She was a loser and a petty thief, she was not on Elaine her sister's level, Elaine was glamorous and elegant and Elaine would charm a two head snake with her smile and style. By Gwendolyn being there this would help Mrs. Ada Lee Mays Jones why she was at her beauty salon named Co-Op Beauty Salon (located between 3rd and 4th Avenue North and 17th Street North next to Nelson Brothers Cafe where its located on the opposite corner of the Old Historical Carver Theatre.

Mrs. Ada Lee Mays Jones had been a well known cosmetologist for years in Birmingham, Alabama. She's had her own beauty salon for nearly 45 years before she retired after her mother's death in 1985. Mrs. Jones had attended Ruth Poro Beauty College in the late 1930's and had graduated as a top stylist.

Gwendolyn who has a sleeping disorder start's falling asleep at Mrs. Jones home, as usual she's back hanging around Mrs. Jones home, as though she's concerned about her grandmother, Gwendolyn motive is that she knows that her grandmother (Mrs. Anna Wilson Harrell) is the wealthiest african-american in the State of Alabama. She has more money than the black banker A.G. Gaston. Mrs. Harrell's stock investments and shares are worth more than 45 million dollars registered with the Stockham Corporation now know as Crane Valve of North America.

Gwendolyn Hardy Davis gets a big surprise when her grandmother passed away Saturday April 13, 1985, Gwendolyn had a strong desire that she would inherit money from her grandmother Anna Wilson Harrell Estate worth at least 45 million dollars, Mrs. Harrell knew Gwendolyn was a snake and had broken her daughter Ada Lee Mays Jones heart. Mrs. Harrell did not leave Gwendolyn a dime because she had an affair with Ada's husband Percy.

6 months later Mrs. Anna Wilson Harrell "Final Will" would be distributed, she bequeathed Harmony Street Baptist Church money where she had fellowship for over 60 years, her sister who lived in Mobile, Alabama Lucille Blevins who was about 87 years old would benefit. Mrs. Harrell did not leave her only son James Mason Hardy, Sr., who died on January 3, 1985 his 5 siblings would not receive a dime from Mrs. Harrell's "Final Will" that was registered on file at the Jefferson County Probate Court before the corrupt officials who embezzled her daughter Mrs. Ada Lee Mays Jones 45 million dollar estate she received from her mother's estate away, the corrupt officials replaced the true records with fraudulent records as seen attached hereto as Exhibit A(III) Jefferson County Probate Case Number 128419 JUD 2018 PAGE 569 which fraudulently states at (3.) said descendent left assets in Jefferson County, Alabama. All of the properties, real and personal, of which said descendent died seized and possessed are estimated to be worth approximately \$25,000.00, and probably no more. This misconduct was used by the Money Hungry Corrupt Officials involved in the murder conspiracy, murder cover-up, and the fraudulent embezzlement scheme of the Estate of Mrs. Ada Lee Mays Jones, the corrupt officials has done what most criminals do, make bad mistakes, but they are the worst of criminals because of their law enforcement positions they have violated the public's trust and think they will never be investigated because of their judicial connections, no individual is above or beneath the Laws of the United States which is no caste Country.

Elaine Hardy McNabb would be directed by Attorney William (Bill) Dawson to hire his wife Attorney Mary Lee Abele, whose office was directly across the hall from Dawson's office at the Frank Nelson Building off of 1st Avenue North and 20th Street in Birmingham, Elaine would recommend her to (Aunt) Mrs. Mays at this time to get Attorney Mary Lee Abele to draw up Mrs. Jones (1st) "Final Will", Attorney Bill Dawson and Attorney Mary Lee Abele used the same secretary for their two offices, Mrs. Jones was not aware that she was being directed to the Devil's Den.

The secretary would make out the "Final Will" for Mrs. Jones the first and second time, The secretary was a white female who would later in 1989 relay some good information to the petitioner and his wife Iris. She would inform the petitioner and his wife to be very careful and she would state that Attorney William (Bill) Dawson where her desk was located in his office that Dawson and Attorney Mary Lee Abele was husband and wife and not to trust them because they were working with Elaine Hardy and the police trying to get the petitioner and his wife out of the way about your inheritance. The secretary in 1989 after making out a "Power of Attorney" for the petitioner's wife, she would call the petitioner and relay that Mrs. Jones was a sweet person, and that they did not have to do that to her.

she knew her great character and she also knew her true wealth, the secretary had her copies of both transactions concerning making out her "Final Wills".

The (2nd) "Final Will" would not be drawn up until Mrs. Jones 2nd husband James Chester Jones passed away on May 11, 1987. Mr. Jones was a beneficiary on Mrs. Jones "Final Will".

Mrs. Jones after the death of her beloved "Chester" as she affectionately called her husband, Mrs. Jones would again have to use the services of dirty Mary Lee Abele, at this time in her life Mrs. Jones is very saddened because she has in 2 1/2 years time lost her brother James Mason Hardy, Sr. on January 3rd, 1985, her mother Anna Wilson Harrell dies on April 13, 1985, and now she has lost her husband of 18 months (Chester) on May 11, 1987.

There will now be a need for Mrs. Jones to make out a new "Last Will and Testament" the change to her new "Final Will" caused her to be heinously murdered, Gwendolyn Hardy Davis would be living in Mrs. Jones home and would be rummaging through Mrs. Jones personal papers and would find out that Mrs. Jones had revised her "Last Will & Testament" and had reduced her brother siblings expected inheritance with the "New Final Will".

Mrs. Jones was angry with her brothers siblings for their disavowing honor against her she would now award the petitioner and his wife Iris 60% of her 46 million dollar fortune. This made her brother siblings very angry.

Gwendolyn is now very upset again her charm plan she's playing has again backfired, the looser will not receive what she expected once Mrs. Jones passed away, Gwendolyn runs and reveal to her sister Elaine that Mrs. Jones has now changed her "Last Will & Testament" and is now giving her daughter Iris and her husband 60% of her "Last Will & Testament". They now will come up with a spiteful and revenge plan.

Elaine and Gwendolyn now has to come up with a plan to get rid of their Aunt (Mrs. Jones), Elaine new plan would be to go back to Attorney William (Bill) Dawson Law Office, Elaine first would have to inculate dirty William (Bill) Dawson in on the plan to persuade his dirty wife Mary Lee Abele to come in on the plan.

Elaine knows that she can not devise a scheme to get rid of her Aunt unless she knows that her "Last Will & Testament" will be hidden from record registered at Jefferson County Probate.

Florence handled the proceeding when Mrs. Jones "Final Will" was registered on record at the Jefferson County Probate Court.

Attorney William (Bill) Dawson and Attorney Mary Lee Abele first task would be to inculate Jefferson County Probate Judge Orris H. Florence in on the murder and embezzlement scheme of the Estate of Mrs. Ada Lee Mays Jones, they succeed in inculating Judge Florence in on the embezzlement scheme.

Jefferson County Probate Judge Orris H. The murder conspiracy will now have to be enacted and carried out by Gwendolyn Hardy Davis and her sister Iris Elaine Hardy McNabb. The three culprits Attorney Mary Lee Abele, Attorney William (Bill) Dawson, and Jefferson County Probate Judge Orris H. Florence will stay in the background and wait until the murder is carried out before Mrs. Jones records will be replaced with fraudulent records. (See Attached Hereto Exhibit A(III)) and see the fraud that Judge of Probate Orris H. Florence would commit exactly one week after Mrs. Jones murder with Gwendolyn Hardy Davis and her sibling stating that Mrs. Jones Estate was worth a mere \$25,000.00 when the hearing was held on November 23, 1988 and on the same date he would award Gwendolyn Davis as the Administrator of Mrs. Ada Lee Mays Jones Estate. Probate Judge Florence is so corrupt that he did not place any newspaper articles for any other family members to acontest the Estate of Mrs. Jones, Judge Florence is playing his role, he would soon be receiving money from Mrs. Jones bank accounts to his own personal bank accounts as evidence will reveal.

On November 14, 1988 the original architects to devise the dirty scheme to murder Mrs. Jones will now execute their devious plan which will be to poison Mrs. Jones with her favorite dish which is Chinese food, it's her passion, as she always has a unquenchable taste for Chinese food.

Elaine would go to First Avenue North and 69th Street to a local Chinese restaurant located in her neighborhood Woodlawn where she lives and was raised up as a child. The plan would be that Elaine would go and eat at the Chinese restaurant in her neighborhood and she would take her mother (Ethel Mae Dallas Hardy), she's using her mother as an alibi if something goes wrong with the cold pre-meditated murder plan of Mrs. Jones to hide her estate records, Mrs. Ethel Mae Dallas Hardy is unaware

of Elaine's scheme which would be to call Gwendolyn at Mrs. Jones home and ask if she wants something to eat, which Gwendolyn will reply yes and also bring Mrs. Jones some food, Gwendolyn and Elaine knows that Mrs. Jones is working in her yard as usual.

Elaine is using her mother (Ethel Mae) as a patsy when she took her to lunch at the Chinese restaurant, Gwendolyn is observing Mrs. Jones in the yard and has been countering her every move and the unsuspecting Mrs. Jones is not aware of the dark evil cold pre-meditated murder conspiracy that is about to happen to her, she is in grave danger why she's working in her yard about to be poisoned with the Devil's Chinese Rice.

The motive for Elaine to take her mother to lunch is to use her for an alibi, it would be that if something goes wrong she would not be the primary suspect and the misconduct would be against her sister Gwendolyn Davis who Elaine is now using to fatally poison Mrs. Jones Chinese food. The plan will consist of once that Elaine placed her food order and Mrs. Ethel Mae Dallas Hardy food order. She will call Gwendolyn and ask her does she want some food to eat, and at this point Gwendolyn would say yes and she will also tell Elaine to order Mrs. Jones some food also.

Elaine is going to carry out her food and her mother's food, Elaine will have her own mother Mrs. Ethel Mae Dallas Hardy carry out, Gwendolyn and Mrs. Jones Chinese food. Elaine is putting protection on herself to make sure if the fatal poisoning back fires to make it appear that her Aunt died of natural causes, this ruse scheme would prevent the misconduct from leading back to her, she's also using Gwendolyn Davis as a patsy, Elaine will have her mother as an alibi that she never touched the Chinese food that would be taken in to her Aunt (Mrs. Jones) home

to fatally poison her.

There's another problem going on for Elaine, her mother hadn't been to Mrs. Jones home in nearly 29 years because of a dark family secret that had happen to Elaine as a girl, her father James Mason Hardy, Sr. (Mrs. Jones eldest brother and only sibling) had been molesting Elaine and had gotten her pregnant when she was 14 years old and she had a child by her father's name Michael Jerome Hardy who passed away 02-29-10.

Mrs. Ethel Mae Dallas Hardy who was Mrs. Jones sister-in-law and she calls her "sister" had known Mrs. Jones since she had been dating her brother James since they all went to A.H. Parker Industrial High School in Birmingham, Alabama. Mrs. Hardy and Mrs. Jones both were cosmetologists and had attended Ruth Poro Beauty College together in Birmingham, Alabama.

Mrs. Jones and Mrs. Hardy was the best of friends, plus Mrs. Jones was helping raise Gwendolyn Hardy Davis when she was growing up as a adolescent too. Mrs. Jones treated Gwendolyn as if she was her own daughter, Mrs. Jones had no children of her own.

There had been a strained relationship between Mrs. Hardy and her mother-in-law and sister-in-law because of the incesteous relationship that had happened between her husband James and her daughter Elaine. Mrs. Anna Wilson Harrell had caught her son molesting Elaine when she was about 14 years old at her home 1208 9th Avenue, South Birmingham, Alabama.

Mrs. Ethel Mae Davis Hardy would call the petitioner's wife at her home one day later which would be November 17, 1988 in Perrine, Florida after the death of Mrs. Jones and stated to her in a phone conversation

that she did not want to go to Mrs. Jones home with Elaine and she would go on to tell Elaine that she hadn't been to Mrs. Jones home in 29 years, Elaine would reassure her mother that she would not go in Mrs. Jones home but would blow the car horn, then that way Gwendolyn could come out the house and retrieve the food and that way Mrs. Jones would not know that she (Mrs. Ethel Mae) was outside her home.

Elaine knew that she was playing her role, and she was scheming and using her mother as an alibi, Mrs. Ethel goes on to tell her grand-daughter before she hung up the phone that Elaine and herself had pulled up with the Chinese food, and after they pulled up to Mrs. Jones home Mrs. Hardy noticed that Mrs. Jones had on yard clothes and was working in her front yard, and when Mrs. Jones noticed her she was glad to see her, Mrs. Jones smiled and Elaine then blew the horn and Gwendolyn came out of Mrs. Jones home and retrieve the food.

Mrs. Ethel Mae Dallas Hardy would go on to tell her grand daughter that Mrs. Jones was happy to see her at her home, and that they had happily chatted and that Elaine and herself did not go into Mrs. Jones home, and that they had pulled off after the chat between Mrs. Jones and herself.

Mrs. Ethel Mae Dallas Hardy would say two days later after seeing Mrs. Jones that she would get a call early in the morning from Gwendolyn stating that Mrs. Jones had died at her home on Wednesday, November 16, 1988 and was pronounced dead at 6:37 A.M. by the Coroner.

When, Mrs. Ethel Mae Dallas Hardy hangs up the phone, the petitioner's wife tells him that her grand mother is scared to death

that she knows her very well, the petitioner knows Mrs. Ethel Mae Dallas Hardy and knows what his wife knows and that is that she will never participate in no evil to anyone, and the petitioner's wife goes on to tell him that it was strange that her grand mother would wait 1 day later to tell her that her Aunt Ada had died on early Wednesday morning and she just decided to call her at her home in Perrine, Florida at 1:00 P.M. Eastern Time on Thursday. Mrs. Jones was closer to the petitioner's wife than any family member that Mrs. Jones had.

The petitioner leaves his house and would return about an hour later, the petitioner's wife is now engaged in a conversation and she's telling the person to check out her Aunt (Ada) because them two dirty bitches my moma (Elaine) and her Aunt Gwendolyn has poisoned my Aunt with that Chinese food. She whispers and tells the petitioner to pick up the other phone and the white male she's talking to is the Jefferson County Coroner. The male on the phone would realize that the petitioner's wife was aware of the misconduct circumstances surrounding the foul play involving Mrs. Jones death and he would make a statement that as a Coroner that he has never seen a murder such as Mrs. Jones in all the years that he's been a Coroner and that there will be a major investigation into the foul play involving her death and then he hung up the phone.

Exhibit A (IV) reveals Mrs. Jones PARTICULARS SURROUNDING DEATH FILE NUMBER: 88-1771. Deputy Coroner Jack A. Parker signature appears in the bottom right hand corner, notice the perjury that the informant Gwendolyn Davis gave to Birmingham Police Officer Richard Landers surrounding the events leading up to her Aunt's death:

- (1) Gwendolyn Davis states that her Aunt had went and purchase food from a unknown named Chinese Restaurant and had gotten sick about 2 hours later, the deceased (Mrs. Jones) experienced nausea, vomiting and stomach cramps. No one else ate at the restaurant with the patient.
- (2) The perjury starts at 10:35 P.M. from Gwendolyn stating that about 44 minutes later the deceased Mrs. Jones would be discharged on November 15, 1988 and prior to being discharged Mrs. Jones would be attended to in Carraway Hospital Emergency Room by a emergency room doctor named Dr. Hoyt Brown Price, II who had attended to Mrs. Jones who was stated to be alert and cooperative and not in any danger resting on a a stretcher.
- (3) The particulars surrounding death have more perjury stating that Mrs. Ada Lee Mays Jones was attended by Dr. Hoyt Brown Price, II and that he prescribed medicine's for Mrs. Jones (1) Vistaril 50mg, IM 2) 6 Phenegran 25 mg Suppositories.
- (4) More perjury is that Mrs. Jones came to Carraway Hospital Medical Center and entered the hospital emergency room at 10:35 P.M. on a stretcher and was alert and cooperative and not in any danger while resting on a stretcher and was discharged 44 minutes later.

The PARTICULARS SURROUNDING DEATH have many fraudulent statements from Gwendolyn Davis who knew that she was rehearsing her story role after she had murdered her (Aunt) Mrs. Ada Lee Mays Jones, the richest African American in the State of Alabama.

August 2011 Carraway Hospital Emergency Room Doctor Hoyt Brown Price, II would be located in Cullman Alabama where he now works for a company called Alabama Web Press located at 1793 Eva Road, NE, Cullman, Alabama 35055.

Dr. Hoyt Brown Price, II would admit to the petitioner and his supporters who was finally able to locate Dr. Price after many years of researching his whereabouts, Dr. Price who is an honest man would admit that in his years as a emergency room doctor he has never prescribed no patient any medicine called "(1) Vistaril 50 mg IM (2) Rx of 6 Phenegran 25 mg Suppository."

To much surprise Dr. Price would ask the question, "What kind of medicine's was the 2 above mentioned medicine's, and state that he's never prescribed any medicine for any of his patients called "Vistaril or Phenegran" in his entire career as prescribing prescriptions.

This misconduct can be explained by the murder conspirators that's involved in the cold pre-meditated henious botch up murder of Mrs. Jones, Elaine and Gwendolyn who have a eldest brother named James Mason Hardy, Jr. nicknamed "Sonny" who had done a career in the United States Army, and at the time of the botch up murder of Mrs. Jones, he resided at 6214 Glenlea Court, Fayetteville, North Carolina.

James Mason Hardy, Jr. had 3 children from his previous marriage to his wife named "Ingrid", he had met her in Germany when he was deployed there by the United States Army. Sonny was having an affair with a friend of his sister Elaine, her name is Jerri and she was married and her husband was employed with the United States Postal Service. Jerri worked as a registered nurse in the emergency room at "Carraway Hospital Medical Center" for years on.

Jerri is the person who would be inculated by Elaine to get the 2 medicine bottles prescribed "(1) Vistaril (2) Phenegran" that appeared on Mrs. Jones nightstand when she was pronounced dead at 6:37 P.M. on November 16, 1988 by Jefferson County Deputy Coroner Jack A. Parker who would be deceived by Gwendolyn Davis who had fatally poisoned her Aunt on November 14, 1988 with an overdose of liquid powerful heart medication that was mixed with cocaine (See Attached Hereto) as Exhibit A (VI) and see Mrs. Jones "Report of Toxicological Analysis" from the "Alabama Department of Forensic Sciences" which reveals at 69 years of age, .02 mg/dl of Cocaine was detected in Mrs. Jones blood, the powerful heart medicine report is being hidden by Jefferson County Pathologist and Chief Medical Examiner Gary T. Notice attached hereto is Exhibit A(V) which reveals a body diagram for the autopsy of Mrs. Ada Mays Jones that was conducted a few hours after Mrs. Jones was pronounced dead at her residence by Jefferson County Deputy Coroner Jack A. Parker at 6:37 A.M. on November 16, 1988.

Look at Mrs. Jones <u>BACK BODY DIAGRAM</u> and notice Mrs. Jones has on a hospital arm wrist which stated that she had been admitted as a patient at Carraway Hospital Emergency Room at 10:35 P.M. on November 15, 1988 and discharged at 11:19, who would believe if they are longtime citizen

of Birmingham, Alabama that the wealthiest female in the State of Alabama would go to the low budget State Run Carraway Hospital in Birmingham, Alabama and be on a stretcher alive and alert at 10:35 P.M. and "Not In Any Danger" and discharged at 11:19 P.M. which would be about 44 minutes later when Mrs. Jones would be allegedly discharged, there would be no way that if Mrs. Jones was alive and alert that Mrs. Jones would ever go to Carraway Hospital E.R. It's perjury from Gwendolyn Davis to deceive Coroner Jack A. Parker and the Birmingham Police Department.

Notice in the right hand corner Mr. Gary T. Simmons signature, and notice also (Ada Mays Jones B/F 69) (11-16-1988 Coroner Parker) the Registered Nurse (Jerri) is the same individual who supplied for Elaine the hospital band and the powerful heart medication to KILL Mrs. Jones that she got from Carraway Hospital.

This dirty ploy would be to deceive Coroner Parker into believing that Mrs. Jones had died about 6:00 A.M. on November 16, 1988 at 6:37 A.M. about 37 minutes before she (Mrs. Jones) was pronounced dead by Coroner Jack A. Parker who knew from his expertise as being a Coroner that there was no way scientifically possible that Mrs. Jones could have been alive 37 minutes earlier before he pronounced her dead because of the rigormortis that had set up in her body, Coroner Parker knew that she had been dead for at least 36 hours to 48 hours which would be correct, because Mrs. Jones was murdered on November 14, 1988 when Elaine Hardy dropped off the Chinese food that Gwendolyn would later poison to fatally KILL Mrs. Jones out of spitefulness.

In 2008 Carraway Hospital Medical Center would close down and transfer all of their patient records to Southern Records Management in Montgomery, Alabama telephone# 334-394-2355, supervisor over the records is Ms. Nora Purcell.

For the following reasons you have the motive for Mrs. Jones murder and why the corrupt officials in Birmingham, Alabama (Jefferson County in both State and Federal Jurisdiction) would violate their "Oath of Office" and erode the Public's trust so that they could benefit financially from a murder victim's estate, their misconduct will never be swept up under the rug by the Court because there is no Justification for their aberrant turn from Justice.
