This report would have been reported on November 16, 1988, as she was pronounced dead at 6:37a.m. by Jefferson County Coroner Department officer Jack Parker at her residence located at 1124-24th Avenue, North Birmingham, Alabama.

This is a formal request from the family of the above-mentioned deceased family member, (Mrs. Ada Lee Mays Jones), born 12-23-1919, S.S.#416-14-7012, she was pronounced dead on November 16, 1988. She resided at 1124th-24th Ave, North Birmingham, Alabama 35204 as her state of Alabama Death Certificate reveals (attached hereto) state File No. 88-038500, Jefferson County Deputy Coroner Jack A. Parker name appears no where on Mrs. Ada Lee Jones death certificate because he wanted no part of her murder cover up to embezzle her estate that exceeded \$35,000,000.00, thirty five million dollars.

In the past, our family has been given the run around by the City of Birmingham who has the murder investigation records by the City of Birmingham Homicide Division hide in the sensitive files. The United States Attorney's Office for the Northern District of Alabama interceded on December of 1988 and took the murder investigation from the Birmingham Homicide Division to the Federal jurisdiction.

As a Honorable Mayor, William Bell, would you respectfully order the City Attorney's Office of Birmingham to release the pertinent complete file records of the investigation to the family of Mrs. Ada Lee Mays Jones so that Justice will prevail, so I can send the records to the Honorable United States Attorney General's office?

The family of Mrs. Jones at this time has an exceptional need of urgency for the pertinent information, documents and reports sought. The family of Mrs. Jones expects the City of Birmingham to turn over the records and give a response for the requested information within (10) ten business days as requested by law. The family of Mrs. Jones as the requestors asks that the state of Alabama open Records request be given priority and expeditious consideration.

Disclosure of the requested information, documents and records to our family is in the interest of Justice and the records will likely be instrumental into the clarification of Constitutional and legal issues pursued.
