From: One Thousand concerned citizen's from Birmingham, Alabama who has signed this Petition for the Honorable President Barack Obama to administer Justice to Mr. William Anthony Fagnes, who is being held in false imprisonment on an manufactured indictment, fraudulently created and concocted by the United States Attorney's Office in Birmingham, Alabama, (Northern Dist.) This conspiracy orchestrated and conducted by corrupt government official's stems from the embezzlement of more than (35 Million Dollar) estate of the late Mrs. Ada Mays Jones, who was murdered, and the murder covered up by the exact same co-conspirator's with the government.

Re: An abuse of power by corrupted government official's, to remove the heir's of the family estate from society by murder and kidnapping. As the rightful heir of my Aunt's estate, I have been targeted by this Criminal Enterprise operating under the color of law, so that they can utilize and spend funds from the estate of (Mrs. Ada May Jones) in peace. The following evidence reveals the documents of a rich Black woman, outstanding citizen of the State of Alabama, who was murdered for her estate, and when the government found out the value of the estate, they conducted a devious scheme to hide the final Will and Estate that exceeds (35) million dollars, from the records from the Jefferson County Probate Court in Birmingham, Alabama. Following the Coroner's report, an investigation was called by the Homicide Division and Jefferson County Coroner's Office, and when the investigation began as foul play was reported, (Overdose: Mixture of a powerful heart medication mixed with cocaine). The problem here is, Mrs. Jones has never had a heart problem, nor used heart medication. And the second problem is, Mrs. Jones was the pillar of the community, (67) years old, and a devout Christian. Never would and never has touched cocaine or any other illegal drugs in her life. This award winner for the State wide Alabama Garden Club was the ideal citizen, and because she was the wealthiest Black woman in Alabama, she was a target of the powerful and greedy, "who didn't have wealth".

This conspiracy began when the family member's found out that their expected funds in the "Final Will" had been changed, and they were not getting what they were initially told they would be getting. They conspired with the Trustee of the estate, Attorney Mary Lee Abele and her husband, Attorney William (Bill) Dawson to suppress the newly created will until they could murder Mrs. Jones. Because Attorney Mary Lee Abele was in total control of the estate, she knew that this would be an opportunity for her and her husband to live a more lavish life on the money derived from the estate of Mrs. Jones. Mrs. Abele agreed with the plan to murder Mrs. Jones, but Mrs. Abele had to recruit Jefferson County Probate Judge Orris H. Florence to cover up the records and documents at the Court house once the murder took place. This was agreed to by Judge Florence, and the conspiracy began.

The niece of Mrs. Jones, Gwendolyn Davis lived with Mrs. Jones and was the person who gave Mrs. Jones the poison mixture of heart medication and the cocaine cocktail. This concoction was administered in the dinner of Mrs. Jones which was Chinese food from a local Chinese restaurant. Upon receipt of the food from Gwendolyn Davis sister, who picked up the food and dropped it off, when Mrs. Jones was done working in her award winning garden, she came inside to eat, and the poison medication and cocaine mix was already planted in her food. This had caused the death of Mrs. Jones, as she ate here last meal, she died from the cocaine and heart medication mix.

On November 16, 1988, Gwendolyn Davis was interviewed and gave a detailed account of what took place to the deputy Coroner, Jack Parker who was dispatched from Jefferson County Coroner's office. Jack Parker was the one who reported the inconsistency of the time of death that Gwendolyn Davis stated, and the obviously decomposed body of Mrs. Jones. Jack Parker was the person who reported the death as suspicious, as he knew from his examination that Mrs. Jones had been dead for at least 36 hours, and possibly 48 hours before his arrival. Gwendolyn Davis had reported that Mrs. Jones collapsed minutes before she called for assistance. Jack Parker pronounced Mrs. Jones dead at 6:37 a.m. (See Appendix D) Motion to Compel and Other Relief. NOTE: See Interrogatory Questions to Gary T. Simmons.

Once you review the Interrogatory Questions of Gary T. Simmons, who was the Director of the Medical Examiner's at Jefferson County, you can easily see that he falsified the case summary of Mrs. Jones death from the original findings of deputy Coroner, Jack Parker. Gary T. Simmons had obviously taken a suborn from the government official's who were called in to assist with the suppression and concealment of evidence regarding the cause of death, and time of death. For the amount of money at hand, they could have afforded to hire the entire circuit of Alabama's government employees responsible for investigations, and they did.

Evidence provides, the original mastermind of the scheme to murder Mrs. Jones was Gwendolyn Davis's sister, Mrs. Iris Elaine Hardy McNabb, who was later found murdered because she wanted a bigger piece of the estate, two bullets to the back of her head. This was to hush her up from exposing the scheme.



As the initial State conducted their investigation, F.B.I. agent (Drug task force) Jeffery L. Burgess, Asst. U.S. Attorney[s] Billy Lee Barnett, and Robert P. McGregor interceded with the investigation, and re-created evidence that would reflect that the death of Mrs. Jones was of natural causes. Cocaine and heart medication is not, "natural causes". Therefore, this team of corrupt government official's had more of an interest than the murder, but the money.

Obviously, if Gwendolyn Davis, who gave the faulty statement was charged in some way with the death of her aunt, if arrested, she would have exposed the entire scheme. Ms. McNabb's seeking more money from the estate, and a possible leak in the overall conspiracy to embezzle Mrs. Jones estate, she was found with two bullets in the back of her head to cover up the leak, and send a message to anyone else who thought of doing the same. There was no investigation, nor was there any arrest. Considering, the people who would investigate were the ones who set up the murder, an arrest wasn't expected. They all knew, that if Mrs. Jones were exposed as a murder, the media and exposure would not allow them to embezzle the estate from Mrs. Jones "in peace".

The Criminal Enterprise consists of attorney's and U.S. prosecutors who have a long history of working with each other, and have conspired in concert to execute this scheme. The corrupt attorney Bill Dawson would be forced from the State of Alabama murder investigation to have it transferred over to his friend attorney Billy Lee Barnett a career prosecutor employed at the (Southern District) of Alabama. December 1988, Mr. Barnett was special litigator for the United States Attorney's office for N/A, Atty. Bill Dawson would reveal the value of Mrs. Jones estate to Asst. U.S. Atty. Billy Lee Barnett to persuade him to use his power to intercede on the State of Alabama's state investigation.

U.S. Attorney (Billy Lee Barnett) would immediately freeze the estate of Mrs. Jones. Barnett would become a partner for a percentage of the estate with the co-conspirator's in the murder and cover up of Mrs. Jones.

Barnett then recruited a team of corrupt F.B.I. agents to assist with the scheme. His first choice was F.B.I. agent (Jeffery L. Burgess). Burgess would coerce Jefferson County Medical Examiner Gary T. Simmons to take a suborn and falsify Mrs. Jones medical records as to the cause of death.

In March of 1990, Mr. William A. Fagnes would hire Congressman Spencer T. Bachus III's law partner, (Randy Allen Dempsey, Jr.) to represent the family to order Mrs. Abele, Trustee of Mrs. Jones, to read the "Last Will and Testament" of Mrs. Jones.

Congressman Spencer Bachus, who was a lawyer at the time and the head of the Republican party for the State of Alabama, would conspire in concert with Asst. U.S. Attorney Barnett and F.B.I. agent Burgess to deter the original architect's who devised the scheme to fatally poison Mrs. Jones, to embezzle the estate of Mrs. Jones for themselves, and never read the last Will and Testament to this very day.

In 2004, Probate Attorney Abele, attorney Dempsey, Asst. U.S. Attorney McGregor, Barnett, F.B.I. agent Burgess and other co-conspirator's were blaming the murder and embezzlement on each other before the Federal Securities Control and Justice Department official's. There were charges about to be brought up against the Criminal Enterprise regarding the murder, cover up and embezzlement of the estate of Mrs. Jones. But Congressman Spencer T. Bachus III stop the investigation of the estate and suppressed and concealed the investigation and evidence, to save face at the Republican Party and for a cut in the (35) plus million dollar estate of Mrs. Jones.

The last Will and Testament was willed in part to Mr. and Mrs. William A. Fagnes, and Iris Fagnes, but to date, the last Will and Testament has never been read, and the estate has been manipulated by Congressman Spencer T. Bachus and the Criminal Enterprise. This was the motive to assassinate Iris Elaine Hardy McNabb, and set up Mr. and Mrs. Fagnes to spend their life in prison long enough destroy all evidence, or die of old age.

The investigation was stopped by the Bush Administration who realized that if the information got out that the members of the Republican Party were apart of a Murder and Cover up of a citizen of Alabama for her estate, it would have been very bad news for the entire Republican Party Nationally.

From a recent investigation, it has been revealed that the indictment that entrapped William A. Fagnes was issued fraudulently, and therefore, William A. Fagnes is presently being held in false Imprisonment on a manufactured criminal indictment by the co-conspirator's to silence.

McGregor and his co-conspirator's realized that CPA Gerald L. Vines; Phone: (205-592-3619), who was Mr. Fagnes accountant, informed Mr. Fagnes regarding the embezzlement of roughly (28) twenty eight million dollars from Mr. Fagnes, by hiding the money that was frozen once filed with the Jefferson County Probate Court in Birmingham.

The corrupted official's "to this point", have gotten away with Murder and the embezzlement of over (35) thirty five million United States dollars in blood money. They thought that they had committed the perfect Murder and Cover up of this horrific murder of the richest Black woman in Birmingham, Alabama.

The criminal enterprise did not murder CPA Gerald L. Vines because of his family member being a Jefferson County Probate Judge, Edward L. Vines who had informed and given Gerald Vines a copy of the last "Will and Testament", and the evidence that leads to Barnett freezing the estate of Mrs. Jones true value of the estate. Also, the Vines family tree extends to the Military Patriot Lt. General Robert Vines. The evidence that the Vines family is aware of, and Gerald has copies of is the true "Will and Testament. Lt. General Robert Vines should be noted for heading up for the U.S. Airborne all missions in Iraq and Afghanistan and Iraq wars before his return in 2006.

Gerald Vines contacted Barnett, and requested that he release the estate due to the fact that the Fagnes family, (According to the copy of the Will and Testament) was due approximately (28) twenty eight million dollars.

In response to this contact by Vines, Barnett sent (4) four F.B.I. agents from the regional (6) six, brandishing machine guns headed by F.B.I. agent Burgess, a leader in the cover up of the murder of Mrs. Jones. His role was to report that her death was of natural causes. Cocaine and heart medication overdose is not in any way "natural causes", especially when Mrs. Jones never had a heart problem.



Mr. Gerald Vines was clearly told by the F.B.I. agents, that if he said anything regarding the Will and Estate of Mrs. Jones, there would be a \$50,000.00 fifty thousand dollar reward for his life, and Mr. Fagnes life. Considering this was coming from the F.B.I., Mr. Vines did not make mention, because he knew that they have killed and gotten away with it in the past, and could get away with it in the future if he were not careful.

Mr. Rouse, the following Petitions have been signed by the citizen's from Alabama, because in the past, administrations have never said, "nobody is above the laws". In Alabama, the Republican party intercepts, murders, kidnaps and mutilates evidence to enforce their agenda. Therefore, it is the will of the people to expose this powerful criminal enterprise during an administration who openly states, "if a crime is reported, it will be investigated and prosecuted".

The evidence to this point has been suppressed and concealed by the District Court, Appellate Court and the Supreme Court. Efforts have been made to reach out to the members of the Justice Department from the President Obama's Office on down, but, my personal experience has been, this prison camp has stolen thousands of letter that have come in for me, by admission of certain employees here at the camp in response to news articles, which has prompted this signature drive to reach out to your honorable office for assistance. The scheme and conspiracy of Mr. Fagnes being kidnapped, by false imprisonment, as this Southern District has continued to practice Jim Crow law, violate Civil Rights, Human rights and many criminal injustices, "for (35) thirty five million dollars of an African American womans money and estate".

Under the Color Of Law, political and Judicial abuse has been documented and presented to your honorable Office in search of relief. This justice sought is for Mrs. Jones family, friends and Mr. Fagnes, as he has suffered long hard years in prison for being the heir of Mrs. Jones, "while being Black".

The record shows, due to the political clout of Congressman Bachus III, the Justice Department in the past administrations, which are probably also in this administration have also suppressed and concealed the evidence submitted to their office. [See Exhibit (6)]
