Dear Dr. Hoyt Brown Price 2nd,

This correspondence is from the family of the late Mrs. Ada Lee Mays Jones who passed away on 11-16-1988. She was pronounced dead at her residence, 1124-24th Ave., North Birmingham, Alabama at 6:37 a.m. by Jefferson County Deputy Coroner Jack A. Parker.

At this time Dr. Price, the family of Mrs. Jones would respectfully request to you to confirm or deny the following questions pertaining to "Particulars Surrounding Death" that appears attached here to that reveals your name as the doctor who attended to Mrs. Ada Lee Mays Jones at 10:45 p.m. on 11-15-1988 approximately 8 hours before Mrs. Jones was pronounced dead at Carraway Hospital Emergency Room.

Dr. Hoyt Brown Price 2nd, you was alleged to be the doctor who attended to Mrs. Jones and also the same emergency room medicine doctor who had prescribed the two different medicine bottles that was on Mrs. Jones night stand at her residence when she was pronounced dead on 11-16-1988 at 6:37 a.m.

Dr. Price, as you read for yourself the "Particulars Surrounding Death" you can make your own determination when you answer the following questions that appears in the following manner:

- (1) Dr. Hoyt Brown Price 2nd, were you employed as an emergency room medicine doctor at Carraway Hospital Emergency Room on 11-15-1988?
- (2) Dr. Price, did you attend to Mrs. Ada Lee Mays Jones on 11-15-1988 at 10:45 p.m. as revealed in the "Particulars Surrounding Death" for Mrs. Jones?
- (3) Dr. Price, did you prescribe the two different medicines for Mrs. Jones on 11-15-1988 at Carraway Hospital Emergency Room; [1]Vistaril 50mg., I.M. [2]RX. of 6 phenegnan 25mg. Suppos?
- (4) Dr. Price, do you have any recollection as being the doctor who attended to Mrs. Jones on 11-15-1988 at Carraway Hospital Emergency Room?

(5) Dr. Price, will you confirm or deny that you did not attend to Mrs. Jones on 11-15-1988 in the emergency room at Carraway Hospital?

(6) Dr. Price, have you ever since becoming an emergency room medicine doctor wrote for any patient at Carraway Hospital Emergency Room any medicine, prescription by the names of Vistaril 50mg., I.M. and RX. 6 Phenegnan 25mg. Suppos?

The following documents attached here to:

(1) "Particulars Surrounding Death" for Mrs. Ada Lee Mays Jones dated: 11-16-1988, states that a Dr. Hoyt Price attended to Mrs. Ada Mays Jones on 11-15-1988.

(2) Jefferson County Coroner Medical Examiner's Office Body Diagram for Mrs. Ada Lee Mays Jones reveals a hospital medical band from Carraway Hospital that stated "Dr. Hoyt Price" was the doctor who attended to Mrs. Ada Lee Mays Jones at Carraway Hospital Emergency Room on 11-15-1988.

(3) Report of Toxicological Analysis case no: 27-89-25658 for Mrs. Ada Lee Mays Jones dated: 11-18-1988, this document reveals at 69 years of age Mrs. Jones who was a devout Christian and the pillar of her community at the time of death had 02. mg/dl of "cocaine" in her blood stream.

(4) State of Alabama "Certificate of Death" for Mrs Ada Lee Mays Jones (state file no. 88-038500). This document reveals that Jefferson County Deputy Coroner Jack A. Parker who pronounced Mrs. Jones dead at 6:37 a.m. would not sign his name as the physician who pronounced Mrs. Jones dead at her residence. He knew that she had been dead for at least 36 hours.

Coroner, Jack A. Parker wanted no part in the murder cover-up of Mrs. Ada Lee Mays Jones, when in fact he knew she had been murdered on 11-14-1988 and that Dr. Hoyt Brown Price did not attend to Mrs. Jones as the "Particulars Surrounding Death" attached here reveals. Deputy Coroner, Jack A. Parker knew that Dr. Hoyt Price name was used in a fraud as part of the murder conspiracy of Mrs. Ada Lee Mays Jones. Parker would not take a "suborn" from the murder conspiritors of Mrs. Jones death to embezzle her estate.

Honorable, Dr. Hoyt Brown Price 2nd, the family will respectfully ask you to get the document notarized by a notary public when you answer the questions attached, that you are truly Dr. Hoyt Brown Price 2nd.
