

The petitioner continued to drive past Mrs. Jones residence, you could look directly into Mrs. Jones home from the street and look through the sheer white curtain shades, the window curtains were wide open and you could see Assistant U.S. Attorney Billy Lee Barnett and see another white male who was about 50-60 pounds heavier at this time than he was when the petitioner last seen him in year 2002 and he was Assistant U.S. Attorney Robert P. McGregor, Jr.

The money hungry corrupt officials at Mrs. Jones home was looking and rummaging through Mrs. Jones home searching for cash money that the petitioner had told Randy Allen Dempsey, Jr. about the time he had seen Mrs. Jones with about \$100,000.00 cash. Mrs. Jones would always tell the petitioner that she always kept about \$250,000.00 at her home at all times, and if the petitioner should ever need more money that that he should let her know ahead of time and she would get it for him, the petitioner would tell Attorney Randy Allen Dempsey that she kept the money downstairs.

The next day after the petitioner had seen Attorney Randy Allen Dempsey, Jr. at Mrs. Jones home, the petitioner would go to his office at 1122-22nd Street, North Birmingham, Alabama and Mr. Dempsey would not speak a word about he and his partners in crime was searching Mrs. Jones home the night before, Mr. Dempsey was acting non-chalant at his office.

The petitioner knew that Mr. Dempsey was too big of a coward to threaten Assistant U.S. Attorney Billy Lee Barnett and F.B.I. agent Jeffery L. Burgess out of the way from their Role of using their police

powers to conceal the circumstances and motive for Mrs. Jones murder so that they could join forces with the original architects who devised the evil scheme to fatally poison Mrs. Jones so that her "Last Will and Testament" would be hidden from record at the Jefferson County Probate Court.

Attorney Randy Allen Dempsey had made a deal to threaten the original architects who had devised the scheme of fatally poisoning Mrs. Ada Lee Mays Jones out of the way, he would threaten them to abandon the embezzling scheme of the 46 million dollar estate of Mrs. Jones.

There was no way he had enough heart to threaten Assistant U.S. Attorney Bill Barnett and F.B.I. agent Jeffery L. Burgess out of the way, but witnesses has told the petitioner the punk Dempsey looks bad and is paranoid and presently stressed out and eyes have the appearances of a basset hound dog with very black and dark meat under his eyes.

August 1990 Dempsey would pressure the petitioner's wife Iris for months to have her mother Iris Elaine Hardy to come to his office so that he could try to extort Iris Elaine Hardy away from the scheme with the evidence that he had gathered against the original architects to devise the scheme to fatally poison Mrs. Jones.

Attorney Randy Allen Dempsey, Jr. knew that Bushelon Funeral Director Annie ~~Bushelon Holt~~ had allowed Iris Elaine Hardy and her brother James Mason Hardy, Jr. to impersonate the petitioner and his wife and forge Mrs. Ada Lee Mays Jones burial policies, as the petitioner and his wife was to receive the money from Mrs. Jones life burial policies after this

misconduct Annie Bushelon Holt would cash the burial policies and turn the money to cash and she would receive a percentage of money that would exceed \$350,000.00. This is the first money that the original architects to devise the scheme to fatally poison Mrs. Jones had collected the new partners got their cut of the Mrs. Jones burial policies such as Assistant U.S. Attorney Bill Barnett, Assistant U.S. Attorney Robert P. McGregor, Jr., F.B.I. Agent Jeffery L. Burgess and his dirty crew of F.B.I. agents who had used their police powers to conceal Mrs. Jones heinous murder.

Jefferson County Probate Judge Orris H. Florence would as evidence will reveal be sending money from Mrs. Jones bank account to his own personal bank account soon after the cold premeditated murder of Mrs. Jones.

Attorney Randy Allen Dempsey, Jr. who would know the true wealth of Mrs. Jones assets and he knew also that Assistant U.S. Attorney Bill Barnett had interceded on the State of Alabama murder investigation of Mrs. Jones and had frozen Mrs. Jones assets that was being hidden from the record at the Jefferson County Probate Court. The same information and evidence that CPA Gerald L. Vines possessed.

Attorney Randy Allen Dempsey, Jr. knew from his investigation into Mrs. Jones wealth that the Jefferson County Probate Court held a hearing on November 23, 1988 which would be exactly a week after Mrs. Jones had been fatally poisoned and pronounced dead on November 16, 1988 the hearing was a fraudulent hearing stating Mrs. Jones "Last Will and Testament" and her assets was not more than \$25,000.00. (See Attached Hereto is Exhibit A (III)) Jefferson County Probate Case Number 128419 JUD 2018 PAGE 569, notice where you see Elaine Hardy, niece 44, competent, died by her own name on the following page Case Number 128419

JUD 2018 PAGE 570, notice Iris Elaine Hardy signature for her name.

The evidence that Mr. Dempsey had on Elaine Hardy, that would be major part of the murder scheme of Mrs. Jones to embezzle her estate.

Attorney Randy Allen Dempsey, Jr. knew that Iris Elaine Hardy had forged her daughter's name on Mrs. Ada Lee Mays Jones insurance burial policies. This was a significant part of Mrs. Jones murder conspiracy that would be concocted by the original architects to devise the evil scheme to fatally poison Mrs. Jones, Elaine who has the same name as her daughter except their middle names are different Elaine "e" Chinesea her daughter middle initial is "c", both women uses their maiden names that appear on both women State of Alabama driver's licenses mother and daughter signs their names with their middle initials, For Example: (1) Iris e. Hardy, (2) Iris C. Hardy, Elaine would forge her daughter's name on Mrs. Jones burial policies making her middle initial "e" appear to be "c" on her State of Alabama driver's license.

When the original architects who devised the scheme to fatally poison Mrs. Jones, all of the major conspirators knew the contents of Mrs. Jones "Final Will" since they knew the contents of Mrs. Jones "Final Will" they would now use the scheme that allowed Elaine to impersonate her daughter with Mrs. Jones State of Alabama death certificate once her death was ruled of Natural Causes and they would deceive the bank where Mrs. Jones kept her safety deposit boxes.

The "Final Will" would allow only the petitioner or his wife to enter Mrs. Jones safety deposit boxes, since the murder of Mrs. Jones on November 14, 1988 had backfired on the original architects who devised the evil scheme to fatally poison Mrs. Jones to hide her "Final Will" from record.

The willing participants who conspired to fatally poison Mrs. Jones to benefit financially from her estate would have to now enlist dirty AUSA Bill Barnett to violate rules of the Justice Department and Congress using his police powers to obstruct Justice and hinder the murder investigation of Mrs. Jones cold pre-meditated murder.

This is why Attorney William (Bill) Dawson would have to inculcate Assistant U.S. Attorney Bill Barnett to intervene on the State of Alabama murder investigation of Mrs. Jones death so that Gwendolyn Hardy Davis who is the primary suspect in the foul play circumstances surrounding her Aunt's death would not be charged for the botch up murder that surely would have been spotlighted to the media and public.

The culprits needed desperately for Mrs. Jones death to be ruled Natural Causes instead of Homicide which it truly was and presently don't have no Statue of Limitations for the crime.

Attorney Randy Allen Dempsey, Jr. investigation would reveal that Mrs. Jones burial policies had been cashed in by Iris Elaine Hardy who had impersonated her daughter Iris Chinesa Hardy and forged Mrs. Jones burial policies Elaine would inculcate Bushelon Funeral Home Director Annie Bushelon Holt, Elaine had been for years on Bushelon Funeral Director Aubrey Bushelon mistress, Mrs. Ada Lee Mays Jones use to sometime do her clients hair and their family members hair when they passed, Bushelon Funeral Home is located at 800 14th Street, Birmingham, Alabama 35211 and would be the place that Mrs. Jones would perform the hair jobs at. The Bushelon Funeral Home (SEE INTERROGATIVE QUESTIONS ATTACHED HERETO AS EXHIBIT A (VII)D that was directed to Mrs. Annie Mae Bushleone Holt by the petitioner that she refused to answer under the penalty of perjury due to her guilt of allowing Elaine to forge her

daughter Chinesa's name which Mrs. Holt would turn to cash at least \$400,000.00 in cash to Elaine for her and the original architects who had devised the scheme to fatally poison Mrs. Jones. The new partners Assistant U.S. Attorney Bill Barnett, AUSA Robert P. McGregor, Jr., and F.B.I. agent Jeffery L. Burgess and more dirty F.B.I. agents would receive their percentage of the fraud insurance policies swindle for covering up the heinous murder of Mrs. Jones this misconduct would take place January - February 1989. This would be the dirty culprits first money that they received from the estate of Mrs. Jones that would not alarm the Internal Revenue Service or the Securities and Exchange Commission.

Attorney Randy Allen Dempsey, Jr. who had become a desperate man on how he would muscle his way in on the embezzling scheme of the estate of Mrs. Ada Lee Mays Jones would now after him failing for months for Elaine to come into his office after sending threats to Elaine through her daughter the petitioner's wife Chinesa.

The threats from Mr. Dempsey to Elaine would be that he would go public with the reason for the heinous cold premeditated murder of Mrs. Jones if Elaine did not come to his office, Elaine flat out refused to go to Mr. Dempsey's office that is called the Devil's Den by Dempsey's clients.

The petitioner's wife (Chinese) had started clowning on her mother Elaine at every family gathering about Elaine and her sister (Gwendolyn) evil involvement in killing their (Aunt Mrs. Jones) because she had reduced their benefits from her "Final Will".

Elaine finally agreed to see Mr. Dempsey. The petitioner's wife had awakened him about 8:00 A.M. and had told him that Elaine (her mother) had agreed to go to Mr. Dempsey's office to see what he wanted to discuss with her.

The venomous money hungry Attorney Randy Allen Dempsey, Jr. finally is going to meet Elaine who was the spiteful malicious mastermind of the original architects who had devised the evil scheme to murder her (Aunt Mrs. Ada Lee Mays Jones) so that her only daughter Iris Chinese Hardy Fagnes and the petitioner would not one day benefit and inherit 60% of Mrs. Ada Lee Mays Jones estate that would be worth approximately worth 28 million dollars depending upon the fluctuation of her bequeathed stock shares she had inherited from her mother Mrs. Anna Wilson Harrell who made investments and was a major shareholder into the Stockham Corporation now known Globally as Crane Valve of North America.

The petitioner knew Attorney Randy Allen Dempsey, Jr. morning daily schedule and knew also that Dempsey usually arrives back from Court or from any appointment that he has early in the morning and will arrive back between 10:30 to 11:00 A.M. at his office located at 1122 22nd Street, North Birmingham, Alabama.

The petitioner wakes up and get's ready and heads up to Mr. Dempsey's office and rides up and down the street. The petitioner intentions was to

remain undercover. The petitioner is waiting to spot his mother-in-law (Elaine) when she arrives at Mr. Dempsey office. Attorney Randy Dempsey pulls up in his white Lincoln Continental and goes inside his office.

The petitioner continues riding back and forth between 11th Avenue and 12th Avenue North, the petitioner decides to park up the hill by the nursing home off of 22nd Street North about 1/4 block North of Mr. Dempsey's office. The petitioner has a clear view of Mr. Dempsey office.

Mr. Dempsey has already been told by the petitioner several times that he knows Elaine very well and knows that she will not budge from no threats from anyone and plus the true facts is that Elaine knows she has a big advantage because she is now partners with Assistant U.S. Attorney Bill Barnett and F.B.I. Agent Jeffery L. Burgess in looting her (Aunt Mrs. Jones) 45 million dollars worth of stock away from the Stockham Corporation.

There's another dirty scheme that Dempsey has up his dirty sleeve from day one of him gaining knowledge about Mrs. Jones estate and that is to manipulate the petitioner's wife (Chinesa) and never let her know that Mrs. Jones had bequeathed the petitioner and his wife 28 million dollars from the "Last Will and Testament" he's going to embezzle the money for himself.

Attorney Randy Allen Dempsey, Jr. plans has been from day one to double cross the petitioner and his wife out of their inheritance. The punk Dempsey have bowed down and made a deal with dirty Government Attorney's and Dirty F.B.I. Agents that they could still receive their promised percentage of MRs. Ada Lee Mays Jones estate for their dirty involvement.

of using their police powers to intercede on the State of Alabama murder investigation of the State of Alabama wealthiest female (Mrs. Jones). Dempsey who talks bad about the F.B.I. behind their back was an agent for 6 months and a Government Attorney for a few months as well before he was sent to Congressman Spencer T. Bachus, III law firm to become a fixer with the Government attorneys employed for the Northern District of Alabama.

Dempsey is a parasite so he looks for the weakest link that would be to get to abandon the fraud scheme of the 46 million dollar estate of Mrs. Jones so he will now extort Attorney Mary Lee Abele, Attorney Bill Dawson, Jefferson County Probate-SUPERNUMERARY Judge Orris H. Florence, Iris Elaine Hardy, Gwendolyn Davis and their siblings out of the scheme that was involved in the fraudulent heir scheme involved also is Attorney Margaret L. Lathum who was present on November 23, 1988 as said Attorney who represented Gwendolyn Davis and her siblings at the fraudulent heir hearing with Probate Judge Orris H. Florence for Case Number 128419 JUD 2018 PAGE 569. See attached hereto Exhibit A(III)A Fraudulent Probate Records for Ada L. Mays Jones.

It would be very easy for Mr. Dempsey to extort Attorney Mary Lee Abele, Attorney Margaret L. Lathum and Jefferson County Probate Judge Orris H. Florence out of the way because of their misconduct in knowing that they were well aware that Mrs. Ada Lee Mays Jones "Last Will and Testament" was registered on file with the Jefferson County Probate Court (Birmingham Division) when they had the fraudulent hearing on November 23, 1988.

Dempsey knew also that there was foul play involving the death of Mrs. Jones that her "Final Will" would be hidden from record. Dempsey as being

an former F.B.I. agent, Government Attorney would easily be aware that Iris Elaine Hardy could not carry out the murder scheme of her (Aunt Mrs. Jones) unless it was agreed prior by the Trustee of Mrs. Jones "Last Will and Testament" and Judge of Probate Orris H. Florence that once Mrs. Jones murder was carried out to make it appear that she died of natural causes her "Final Will" would be hidden from record.

The original architects who devised the evil scheme to benefit financially from the murder victim's estate which is provided in State of Alabama Law as pursuant to murder and fraud statue (15-3-5) which states that there is never any statue of limitations on both crimes for murder and embezzlement when a victim is murdered for the victim's assets.

Dempsey knew that Attorney Mary Lee Abele had committed a fiduciary crime with Judge of Probate Orris H. Florence who had not placed any public notices concerning any Probate Notice IN RE: The Estate of Mrs. Ada L. Mays Jones, deceased: There was never any notice from Judge Florence given that all persons having claims against said estate are hereby required for any family members or any persons with any claims to protest Gwendolyn Davis as being granted administratix over the Estate of Mrs. Jones. Judge Florence would violate the law by appointing and granting Gwendolyn Davis as Administratix of Mrs. Jones Estate on November 23, 1988, the very same day that she had applied to be the administratix, Judge Florence who was in on the murder scheme of Mrs. Jones is doing his assigned role in the scheme to embezzle Mrs. Jones estate.

Dempsey knew that Judge Florence was involved with the scheme and that all of the evil conspirators had committed cold pre-meditated murder which is still presently today has no statue of limitations for capital murder for the evil crime with the penalty being the death sentence for the conspirators who conspired to murder Mrs. Jones for her assets.

Dempsey knew also that there would be no problem especially to remove Attorney Mary Lee Abele who was the Trustee of the "Final Will" of Mrs. Jones, Attorney Abele had committed a fiduciary crime that involves murder and fraud.

Attorney Mary Lee Abele had the petitioner and his wife (Chinese) to make over (6) six appointments for her to read the "Final Will" of Mrs. Ada Lee Mays Jones. Attorney Mary Lee Abele was acting paranoid and afraid and she reneged every time. The petitioner could tell that Attorney Mary Lee Abele was scared and wanted out of the murder and fraud scheme of Mrs. Jones to embezzle her estate because of the exposure that it was not a ironclad murder and fraud scheme anymore. The true facts presently today would be that Mary Lee Abele has committed a fiduciary crime and has not probated Mrs. Jones "Last Will and Testament" as she was sworn to do and give the true heirs there assets due them from the estate of Mrs. Ada L. Mays Jones worth at least 46 million dollars in 1988.

Attorney Randy Allen Dempsey, Jr. knew that he could easily spook away the original architects that was involved in the heinous crime away from the scheme except Iris Elaine Hardy. The petitioner had posted up and was now watching Dempsey's office and he now sees for himself that Elaine is now pulling up in her blue Nissan station wagon and gets out of her station wagon and goes into Mr. Dempsey's office. Elaine is confident and already knows that Mr. Dempsey is too big of a coward and will not expose Assistant U.S. Attorney Bill Barnett and F.B.I. Agent Jeffery L. Burgess roles in the murder cover-up and embezzling scheme which both dirty officials never liked Mr. Dempsey muscling his way in on the FRAUD scheme that they were involved with anyway since they know that CPA Gerald L. Vines is aware that the petitioner and his wife is due 60% of Mrs. Jones 46 million dollar estate, Dempsey takes advantage of this knowledge and muscled his way in on the evil scheme.

Mr. Dempsey was using a fraudulent power of attorney that he duped the petitioner's wife (Chinesa) to sign. Chinesa did not not know what she was signing. Dempsey was using this fraudulent power of attorney as a bartering tool to intrude in on the impostor's fraudulent embezzling scheme of the estate Mrs. Jones.

Elaine is now in Mr. Dempsey's office which he will now try to extort Elaine out of the way with the evidence that has gathered such as Mrs. Jones true wealth, the murder and murder cover-up of Mrs. Jones, Judge Orris H. Florence freezing Mrs. Jones estate then sending money from her bank accounts to his own personal bank account.

Dempsey will now tell Elaine that there will be no prosecution of you for conspiracy to commit murder against your Aunt to embezzle her estate. Dempsey will tell Elaine that there will be no prosecution of you impersonating your daughter forging her name and cashing in Mrs. Jones burial policies at Bushelon Funeral Home.

The petitioner now sees Elaine coming out of Mr. Dempsey's office and is walking to her car. Mr. Dempsey is behind Elaine and trying to say something to Elaine. The petitioner could tell for himself that Elaine is ignoring Mr. Dempsey.

Elaine gets in her car and pulls off and doesn't look back at Mr. Dempsey who is now pacing up and down the sidewalk looking in shock. His devious plan of extorting Elaine out of the way has backfired on the snake attorney Dempsey.

The petitioner gets out of his car and tells Mr. Dempsey that I told you that Elaine wasn't going to budge. She knows that she's got the Government attorneys and dirty F.B.I. agents down with her and she knows that you're not going to tell on them.

Mr. Dempsey utters to the petitioner to bring your wife (Chinesa) by here at 1:00 P.M., remember that Dempsey is double crossing the

petitioner and his wife by not letting them know how much money they are due from the estate of Mrs. Jones which est. would be appoximately 28 million dollars. It was important for him to get Elaine to abandon the estate of Mrs. Jones.

The petitioner takes his wife to see Mr. Dempsey at his office which would be be the same office that Mr. Dempsey had received Mrs. Jones personal information as he would immediately find out how much money Mrs. Jones was worth. Mr. Dempsey would come back to his office the following day after receiving from the petitioner Mrs. Jones personal information and after entering his office he would turn red as a beet and fall on his hands and knees and scream as though he had hit the lottery, but what happened is that Mr. Dempsey hasn't hit the lottery but he knows the motive for Mrs. Jones death and he knows that 28 million dollars is due to the petitioner and his wife (Chinesa) which he will never tell them that Mrs. Jones, also bequeathed them her home, jewelry, her insurance burial policies, real estate and etc. on her "Last Will and Testament".

Dempsey would have embedded in his evil deceptive mind that he had hit the estate lottery and he was going to steal the money legally due to the petitioner and his wife for himself.

After the petitioner and his wife leaves Mr. Dempsey's office, Chinesa would tell the petitioner that privately Mr. Dempsey had told her that Elaine her mother had told him that she's going to get what's due to her and that if he tells on her he would have to tell on everybody and then she walks out of his office.

Dempsey continues to spook the other original architects involved away from the scheme such as Attorney Mary Lee Abele and Attorney William (Bill) Dawson, Jefferson County Judge of Probate Orris H. Florence and

Attorney Margaret L Lathum away from the fraudulent heir scheme.

On September 21, 1990 Attorney Margaret L. Lathum would file a Motion To Withdraw as said Attorney of Record for the estate of Mrs. Ada Lee Mays Jones.

The grounds that would be stated by Attorney Margaret L. Lathum, who respectfully moves the Honorable Court (Jefferson County Probate Court) to grant her the right to withdraw and as grounds state the following.

- 1) There has been a breakdown in communication between the attorney and the administrator.
- 2) Said Attorney has written the Administratrix several times to various things that should be accomplished, with a copy to each and every heir known to said Attorney.
- 3) Said Attorney has failed to receive a response from the Administratrix and/or the heirs.
- 4) Said Attorney has given a copy of this motion to the Administratrix and each and every known heir in order for them to be present at the hearing on this cause.

Attorney Margaret L. Lathum is now going to abandon her role out of the scheme , because of Dempsey threats of going public has spooked Attorney Margaret L. Lathum away. She has been inculated in on the scheme to represent the fraudulent heirs who was stating that Mrs. Jones had no "Last Will and Testament".

About 3 weeks later Iris Elaine Hardy McNabb would be gunned down in what appeared to be a robbery at her home on 18th Place Southwest, Birmingham on October 12, 1990. Elaine would die on October 29, 1990 and never would gain conscious.

The purchaser was her mother Ethel Mae Hardy who later would pass away on Monday April, 18, 1994. Mrs. Ethel Mae Dallas Hardy was a good person who never took any role in killing her friend and sister-in-law "Mrs. Ada Lee Mays Jones". Mrs. Ethel Mae Hardy always was aware that her (2) daughters Gwendolyn Hardy and Elaine Hardy had conspired to kill their (Aunt) Mrs. Ada Lee Mae Jones in a spiteful revenge because she reduced their expected benefits from her "Last Will and Testament".

The notice would be making Gwendolyn Davis as the fraudulent administratrix aware that she has not responded to Attorney Margaret L. Lathum telling her to produce various things that should be accomplished for her and her

siblings to maintain their role as the true heirs of Mrs. Ada Lee Mays Jones estate.

Attorney Margaret L. Latham would once tell Gwendolyn Davis and her siblings that their Aunt Mrs. Ada Lee Mays Jones was most likely the wealthiest citizen in the State of Alabama. Birmingham Mayor Richard Arrington, Jr. would say at Mrs. Ada Lee Mays Jones funeral that Mrs. Jones was the wealthiest citizen in Birmingham, Alabama.

Reynolds would take over the fraudulent estate of Mrs. Ada Lee May Jones where fraudulent records would be replaced as seen: ATTACHED hereto as Exhibit A(III)A Case No. 128419 JUD 2018 PAGE 569 which reveals under the following facts (3.) said descendent left assets in Jefferson County, Alabama. All of the properties, real and personal, of which said descendent died seized and possessed are estimated to be worth approximately \$25,000.00, and probably not more.

Attorney Randy Allen Dempsey, Jr., who has now joined forces as the new partner in the embezzlement of the estate of Mrs. Jones. Assistant U.S. Attorney Bill Barnett, Assistant U.S. Attorney Robert P. McGregor, Jr., F.B.I. Agent Jeffery L. Burgess. ET.AL. have now made an agreement with Mr. Dempsey to spook away the murder conspirators. Two days after Gwendolyn Davis was served with the Summons from the Jefferson County

Sheriff's Department on October 10, 1990 her sister Iris Elaine Hardy was gunned down on October 12, 1990. Elaine was shot in the back at her residence when she stepped out her house to warm up her car. Elaine died on October 29, 1990.

Attorney Randy Allen Dempsey, Jr., who was screaming and hollering when he first became aware that Mrs. Ada Lee Mays Jones had bequeathed the petitioner and his wife 60% of her 46 million dollar estate on her "Final Will".

The evil minded money hungry attorney who did not have a decent suit to wear in 1985 when the petitioner first met Mr. Dempsey would around December 1990 after the death of Iris Elaine Hardy would now start smoking expensive cigars and wearing expensive suits and would no longer discuss the estate of Mrs. Ada Lee Mays Jones with the petitioner as he and his new partners, Assistant U.S. Attorney Bill Barnett, Assistant U.S. Attorney Robert P. McGregor, Jr., F.B.I. Agent Jeffery L. Burgess et.al who used their police powers to conceal the heinous circumstances surrounding Mrs. Jones murder conspiracy so that the misconduct would not lead back to Attorney Bill Dawson and his evil mind wife Attorney Mary Lee Abele and Probate Judge Orris H. Florence misconduct of conspiring with Mrs. Jones niece's Gwendolyn Hardy Davis and Iris Elaine Hardy McNabb.

December 1990 as evidence will reveal that the Stockham Corporation headquartered at the time in Birmingham, Alabama would have an emergency meeting, the CEO Herbert Stockham who had graduated from LEHIGH

University as an engineer and is now 65 years of age and he be in shock and would summon The Board of Trustees and the Chief Financial Officer for Stockham Valve Pipe and Fittings, Inc. Mr. Farley to an emergency board meeting to inform them that the 45 million dollars worth of stock that was invested with the Stockham Corporation in Mrs. Ada Lee Mays Jones name that she had bequeathed from her mother Anna Wilson Harrell. The stock was now being pulled out by the new heirs that benefited from Mrs. Jones "Last Will and Testament" which was fraud then and is still an ongoing crime of false misrepresentation.

The original evil corrupt conspirators was forced out of the embezzlement scheme who had conspired to murder Mrs. Jones, after their sudden departure you now have the dirty low life corrupt (1) Jefferson County District Attorney's office employees (2) dirty Government attorney's from the Northern District of Alabama (3) dirty F.B.I. agents assigned from the Birmingham Field Office, Attorney Spencer T. Johnson not to dismiss the two fraudulent rubber stamped State of Alabama indictments for the petitioner in violation of the Speedy Trial Act Provision 18 U.S.C. §3161(b) as established by Congress and clarified by the Supreme Court in the 2006 Ruling Jacob Zedner vs. United States in a (8-1) majority, the Supreme Court has directed all inferior courts to immediately dismiss without further delay all untimely indictments "with prejudice".

The dirty officials who conspired to conceal Mrs. Jones heinous murder so that they could benefit financially wants Federal Judge C. Lynwood

Smith, Jr., Magistrate T. Michael Putnam to direct Honorable Judge Inge P. Johnson to intentionally delay the petitioner from getting Justice because the dirty culprits all of them knows that her ruling will immediately release the petitioner who has been held in false imprisonment for over 11 years due to their misconduct of using a manufactured fraudulent indictment scheme to place the petitioner in illegal custody so that their devious scheme of embezzling Mrs. Ada Lee Mays Jones estate and deceiving the Stockham Corporation would not be disturbed because they thought that they had gotten away with the perfect crime which they now know that they made a bad mistake in framing the petitioner and fraudulently indicting the petitioner in both State and Federal Courts.

There's only one way out for the corrupt officials that's to tell Honorable Judge Inge P. In year 2003 he would secretly blame the murder, murder cover-up crime of Mrs. Jones death on the original architects who devised the evil scheme. cover-up of the murder of Mrs. Ada Lee Mays Jones to embezzle her stock shares away from the Stockham Corporation now known as Crane Valve of North America.

There has been also constitutional violations of the Rule of Law by the Court who has aided and abetted the corrupt officials misconduct to the petitioner which is obstruction of justice for the Court to continue to be bias and pre-judicial to the petitioner in protection of a murder cover-up and fraudulent indictment schemes conducted by the same corrupt officials in both State and Federal Courts.

The petitioner motions since year 2005 starting with the petitioner 2255 memorandum for Case # 2:05-CV-08065-CLS-TMP all the way up to this motion will be posted on the website with Mrs. Jones bank records, her mother Anna Wilson Harrell bank records and stock records with the Stockham Corporation, Mrs. Ada lee Mays Jones "Last Will and Testament" will be revealed that exposes the fraudulent Jefferson County Probate Records for Mrs. Jones wealth attached hereto as Exhibit A(III)A.

Once the World finds out that dirty money hungry Government officials have used their police powers to stop murder conspirators of a wealthy african-american heiress (Mrs. Jones) from being brought to justice so they could benefit financially it will definitely be a outcry from the Public and media and also the Sports World when it's known that Mrs. Ada Lee Mays Jones was a family member of baseball great Willie Howard Mays, Jr. from Birmingham, Alabama. The dirty officials involved are employed at the U.S. Attorney's Office and the F.B.I. Field Office in Birmingham, Alabama and also Randy Allen Dempsey, Jr. have conspired to cover-up Willie Howard Mays, Jr. family member heinous murder it will grab a lot of attention.

The petitioner got experts assisting him in placing his court file documents on the internet that reveals that Magistrate T. Michael Putnam

and Federal Judge C. Lynwood Smith, Jr. was also out to protect their corruption of conspiring to fraudulently indict the petitioner on a manufactured fraudulent indictment scheme that was exposed by the petitioner. The Executive United States Attorney's Office in Washington D.C. their Freedom of Information and Privacy Act Unit pertaining to request no. 03:3921, that there are no indictments on record for September 26, 2001 that Terrell Clement as being Grand Jury Foreman signed against a Mr. William Anthony Fagnes (Petitioner) in the Northern District of Alabama or any U.S. Attorney's office in the United States or the Commonwealth's.
