RE: This is a formal request to the city of Birmingham to release my aunt's (Mrs. Ada Lee Mays Jones) investigation records of her being pronounced dead on November 16th, 1988 at 6:37 a.m. at her residence of 1124-24th Ave, North Birmingham, Alabama. Her Social Security Number: 416-14-7012, Birthdate: December 23, 1919, Residence 1124 24th Ave, North Birmingham, Alabama. The early morning of 11/16/1988 Birmingham Police Officer Richard Landers who was dispatched from the North Birmingham Police Precinct as seen attached here to in the exhibits "Particulars Surrounding Death", would arrive at Mrs. Jones residence and find her dead, her niece Gwendolyn Davis would be the only person there. There was foul play involved in Mrs. Ada Lee Mays Jones death, and due to the inconsistencies that Mrs. Jones niece "Gwendolyn Davis" gave the Birmingham Police Officer Richard Landers who would relay the fraudulent information to Jefferson County Deputy Coroner Jack R. Parker that Mrs. Jones had been pronounced dead, and prior to being pronounced dead, Gwendolyn Davis would also state that Mrs. Jones had attended Carraway Hospital emergency room 8 hours earlier and was attended to by Carraway Hospital emergency room doctor Hoyt Brown Price II who was alleged to prescribed two medicine prescriptions for Mrs. Jones: (1) Phenergan 25mg. (2) Vistaril 50mg. On August 2011, Dr. Hoyt Brown Price II was located and questioned regarding the prescribing of Phenergan or Vistaril medicine to Mrs. Ada Lee Mays Jones while operating as an emergency room doctor. Dr. Hoyt Brown Price II stated that he never prescribed any Phenergan or Vistaril for any patient throughout his career as being an emergency room doctor. Herein the pages of this letter are "Particulars surrounding the death of Mrs. Jones, and further more, Dr. Hoyt Brown Price II stated that he didn't do any lab work on Mrs. Jones when she was allegedly supposed to have been treated at Carraway Hospital Medical emergency room. [See attached hereto on the back page of "Particulars surrounding Death " where it states that Dr. Hoyt Price reported that no lab work was performed.] from Coroner Jack R. Parker expertise from recognizing the rigormortis that had set up in Mrs. Jones body, Coroner Parker knew that she had been dead for at least 36-48 hours, Parker knew that there was no way that she was alive and alert 51 minutes earlier before she was pronounced dead at 6:37 am on 11-16-1988, Coroner Parker knew also that there was no way that 8 hrs. earlier that Mrs. Jones was a patient at Carraway Hospital emergency room being attended to by a doctor Hoyt Price. Coroner Jack R. Parker took Mrs. Jones body with him, without the family consent and authorized an immediate investigation and Autopsy.

The Autopsy immediate revealed that about 36-48 hours after Mrs. Jones died someone forced open her jaws and stuff crackers and chicken noodles down her throat, about 2 days later the toxicological analyst report revealed that Mrs. Jones was given a powerful overdose of heart medication with Cocaine that induced a heart attack on the unsuspecting Mrs. Jones when Chinese food was delivered to Mrs. Jones by her niece Mrs. Iris Elaine Hardy McNabb who was Gwendolyn Davis sister, about 22 months later Iris Elaine Hardy McNabb would be murdered herself. The Conspiracy to kill Mrs. Jones and hide her "Last will and Testament" would take place on 11-14-1988 the last time that anyone would see Mrs. Jones alive or hear from her. Mrs. Jones had taken her two niece's Iris Elaine Hardy McNabb and Gwendolyn

Davis off of her "last will and testament", this why the conspiracy to murder her took place. The Trustees of Mrs. Jones "Final will" was up with the cold pre-meditated murder conspiracy, Mrs. Jones was worth over 45 million dollars, once, Mrs. Jones was dead her "Last will and Testament" would be hidden from record at Jefferson County Probate court and replaced with fraudulent records and after this misconduct the true heirs to

benefit from Mrs. Jones "Final will" would never be notified, then the murder conspirators would fraudulently embezzled the estate for themselves. After Coroner Jack R. Parker starts the murder investigation he will now enlist the Jefferson County District Attorney's Office and the Birmingham Homicide Division then led by Capt. Robert L. Walker. Gwendolyn Davis now becomes the primary suspect in the involvement of her Aunt's heinous murder, the other culprits involved in the murder conspiracy such as Probate Atty. Mary Lee Abele would now be forced to give a proposition to corrupt Government Attorney Billy Lee Barnett to be inculcated into the embezzling scheme if he could use his government power to intercede on the State of Alabama murder investigation of Mrs. Jones and take it from State Jurisdiction to Federal Jurisdiction, then he could become a partner in the 45 million dollar embezzlement. AUSA Bill Barnett takes the suborn and freeze Mrs. Jones estate and take the murder investigation over, which was nothing but a dirty ploy to give Mrs. Jones murder conspirators a pass for murder so that the evil murder conspiracy would not be spotlighted to the public or media. Due to this misconduct the Family of Mrs. Jones is respectfully requesting that the city of Birmingham no longer turn blind eyes and used deaf ears for this evil misconduct. The family of Mrs. Jones is requesting the following; (1) The files that's sealed pertaining to Mrs. Jones murder investigation, that all reports be released.

(2) The November 16th, 1988 report from North Birmingham Police Precinct Officer Richard Landers who was dispatched to Mrs. Jones residence 1124-24th Ave, North Birmingham.

(3) Coroner reports sent to the Birmingham Homicide Division concerning Mrs. Jones death of foul play.

(4) Mrs. Ada Lee Mays Jones and her mother Anna Wilson Harrell tax records with the City of Birmingham, attached here to is Mrs. Jones and Mrs. Harrell Death certificates.

On Mrs. Jones Death Certificate, it states manner of Death, natural causes signed by the pathologist, not Coroner Jack R. Parker who wanted nothing to do with the murder cover up after dirty F.B.I. agents join in on the embezzling scheme of Mrs. Jones 45 million dollar estate.

This request has an exceptional need of urgency for the pertinent information, documents and reports. The family requestor expects the information to be released within 10 business days as prescribed by law and respectfully ask your organization to respect the State open record Act and that this request be given priority and expeditious consideration. Disclosure of the requested information documents and records to the requestor is in the interest of justice the records that the city of Birmingham do maintain from the murder investigation of Mrs. Jones on November 16, 1988 are likely to contribute to the clarification of the constitution of other legal matters and issues.
