SUBJECT: Murder Cover up of the wealthiest Black Woman (Ada Lee Mays Jones)
in the State of Alabama, worth at least \$35 Million Dollars in 1988.
Ada Lee Mays Jones was fatally poisoned and her death is a cover
up by dirty-corrupt Government Drug Attorneys who have conspired
with dirty-local F.B.I. Drug Agents who interceded on a State of
Alabama Murder Investigation, which was nothing but a scheme to give
Ada Jones murderers a pass to escape prosecution. Congressman
Spencer T. Bachus III Law Firm is involved in the theft.

Dear Mr. Robert Mueller,

This correspondent is for you to investigate my truthful allegations which
is the truth before God. I am the true heir to the Estate of Ada Lee Mays
Jones, who was fatally poisoned in a murder scheme on 11/14/88 at her home
1124-24th Avenue North Birmingham, Alabama.

Ada Jones (from here on) was fatally poisoned in a scheme to make it appear
she died of a heart attack in her sleep, which immediately back fired on the
conspirators which consist of Ada Lee Mays Jones nieces, Gwendolyn Davis and
Iris Elaine Hardy McNabb, who was later murdered herself, pertaining to her
not wanting to be excluded from the Estate of Ada Lee Mays Jones.

Iris Elaine Hardy McNabb is my mother-in-law. She was gunned down around September 30, 1990. She is buried at Elmwood Cemetery in Birmingham, Alabama, Lot - 308, Block 49.

When her name Iris Elaine Hardy is checked on the NCIC, you will see her criminal record background as a master thief and con artist. She is one of the original architects to kill her aunt, (Ada Jones), which consists of Ada Lee Mays Jones Trustee of her "Final Will and Last Testament. Attorney Mary Lee Abele, who as of today is afraid for her actions and role of concealing Ada Jones "Final Will" from the true inheritors, in an investigation from the S.E.C., all the culprits was secretly blaming the embezzlement crime on each other which I'll explain briefly.

Attorney Mary Lee Abele's ex-husband, Criminal Attorney William (Bill) Dawson, they was married at the time of the conspiracy to fatally poison Ada Jones with "heart medication and cocaine" to induce a heart attack to make it appear Ada Jones died of a heart attack in her sleep, which immediately called for an autopsy on 11/16/88 at 6:37 a.m., the same day that Ada Jones was pronounced dead by Deputy Coroner Jack Parker, who told me that he never seen a murder as the death of Ada Jones. Reason for his statement, Ada Jones *niece*, dirty-Gwendolyn Davis, who was living with Ada Jones and was being angrily asked to leave Ada Jones home for stealing money from Ada Jones. Gwendolyn was a loser and was used as a patsy to put an overdose of powerful heart medication into chinese food brought over to Ada Jones home by her *sister*, Iris Elaine Hardy McNabb and their mother, Ethel Mae Dallas Hardy, who is also buried in Elmwood Cemetery at Lot - 308, Block 49. Ms. Ethel Mae Dallas Hardy wasn't in on the plan to kill her sister-in-law, Ada Jones. Ethel was used as a patsy and alibi by her daughter, Iris Elaine hardy, who had took her mother with her to buy the chinese food for Gwendolyn Davis. Elaine would state that the chinese food never left her mothers' eyesight.

What really caused the murder was that Gwendolyn Davis was rummaging through Ada Jones papers and found a new copy of Ada Jones "Final Will", and found out that Ada Jones had reduced Gwendolyn and her siblings share of the estate to crumbs, and was leaving to my wife and myself, at least \$28 Million Dollars from Ada Jones Estate, which she inherited from her mother, Anna

Wilson Harrell, a long time employee of Stockham Valve Pipe & Fitting Inc., founded in Birmingham, Alabama in 1903, by William H. Stockham.

Ms. Anna Wilson Harrell, is considered the core maker of stockham Valve Pipe & Fitting Inc., which expanded globally, and now is known as Crane Valve of North America, with the headquarters as of today, is located in Dwoodland, Texas.

Ms. Anna Wilson Harrell was born on December 25, 1898. She died on April 13, 1985. Her Social Security Number is 416-05-3836. During Ms. Harrell's employment with Stockham Valve Pipe & Fitting Inc., she made several investments in the companies stock portfolio, which eventually resulted in a substantial return after it entered into the global market during the Industrial Revolution. Upon the death of Anna W. Harrell, her estate was worth at least \$35 Million Dollars or more, which was conveyed to the only surviving child, Ada Jones.

Ada Jones would be murdered 3½ years later for the assets left to her by her mother. As of today, Ada Jones death is a classical cover up by local employees, government cover up by dirty-money hungry corrupt officials who is stressing and afraid for their actions.

U.S. Attorney Alice H. Martin needs to be immediately by Attorney General Alberto Gonzales, be forced to resign from office for her role of hindering prosecution against her Ex-Assistants, Regional 6 Drug Supervisor, the dirty Billy Lee Barnett, who is the mastermind of stepping in on a State of Alabama Murder Investigation, which was nothing more of a scheme to help Gwendolyn Davis and Iris Elaine Hardy escape prosecution for the murder of their beloved aunt, Ada Jones.

Dirty-Billy Lee Barnett was given a proposition by the Trustee of Ada Jones "Final Will" husband, Attorney Bill Dawson, who is also Iris Elaine Hardy's Criminal Attorney. Elaine Hardy and Attorney Bill Dawson who is the original architects in on the plan to kill Ada Jones with an overdose of heart medication to make it appear she died of a heart attack in her sleep, which subsequently back fired on the conspirators with Probate Judge O.H. Florence in on the plan to benefit financially.

Mr. Florence's role would be, once Ada Jones is murdered, her "Final Will" would be hidden from record, and the true inheritors of Ada Jones "Final Will" would never be notified by the Trustee of Ada Jones "Final Will", Attorney Mary Lee Abele, then the conspirators could embezzle the money for themselves.

On 11/16/88, the morning that Gwendolyn Davis called out to make the discovery of finding her aunt "Ada Jones" dead. Officer Richard Landers, an employee with the Birmingham Police Department, was dispatched to 1124-24th Avenue North, Birmingham, Alabama 35204. Officer Richard Landers was stationed with the North Birmingham Precinct Division, upon arriving, Officer Landers took the information from the informant, Gwendolyn Davis, but who was actually the murderer of her aunt Ada Jones, who had been murdered on 11/14/88.

Gwendolyn Davis, which is shown in the documents, I have supplied to you, Mr. Mueller, which can be found as (Exhibit U) in the Motion for Notice to Clarify the Record, filed 2007, January 4, with the U.S. District Court Northern District of Alabama. Gwendolyn was rehearsing her role, stating to Officer Richard Landers, that at 0545 hrs. a.m., on 11/16/88, that she had given her aunt Ada Jones, Phenegran. Ada Jones would be pronounced dead at 6:37 a.m. by Deputy Coroner Jack Parker, which would be approximately 52 minutes later between the time stupid Gwendolyn lied and stated her aunt was alive and alert.

Officer Richard Landers gave Gwendolyn Davis story to Deputy Coroner Jack Parker on the morning of 11/16/88, who immediately noticed foul play in to her fraudulent story, which immediately on the same day, Ada Jones would be given an autopsy by Pathologist Gary T. Simmons, who would 8 weeks later, falsify Ada Jones State of Alabama Death Certificate, which the Death Certificate can be found in the Response to the Government Argument as (Exhibit R).

Pathologist Gary T. Simmons would take a Suborn on orders of F.B.I. Drug Agent Jeffery Burgess, who would be called in on the plan by Assistant U.S. Attorney Billy Lee Barnett for a percentage of the multi-million dollar estate.

Assistant U.S. Attorney Billy Lee Barnett and F.B.I. Agent Jeffery Burgess, have threatened to kill

C.P.A. Gerald Vines, whose telephone number is 205-592-3619, which I'll explain later in this criminal complaint which is irrefutable, back to Deputy Coroner Jack Parker, who immediately noticed on 11/16/88, the same morning of Ada Jones being discovered dead. Deputy Coroner Jack Parker from his expertise noticed that Ada Jones had been dead from the rigormortis set up in her body, that she had been dead from 36 to 48 hours, and Mr. Jack Parker knew that there was no way for Ada Jones to have been given Phenegran, which is stomach medicine, 52 minutes before he pronounced Ada Jones dead. Mr. Parker knew she had been dead for at least 2 days.

Deputy Coroner Jack Parker notified the Medical Examiner's Office in Birmingham, Alabama and immediately ordered an autopsy and Toxicological Examination, which was performed on Ada Jones body 11/16/88, which is shown in the Notice to Clarify the Record, which is (Exhibit T), which shows "cocaine" in Ada Jones blood.

There are pages missing from the reports. The records for Ada Jones Investigation at the Birmingham Police Department is missing from the files. There is not a report of Officer Richard Landers concerning his report of coming out to Ada Jones home 1124-24th Avenue North on 11/16/88. The culprits that's involved with concealing Ada Jones death to steal her wealth is behind the cover up and all are afraid and begging for a cover up for their roles to benefit financially, which bankers are involved with the corrupt thieves. Their motive is for love of money. They're involved in one of the most heinous crimes in American History and want a cover up to keep Ada Jones death and wealth concealed.

Mr. Mueller, C.P.A. Gerald Vines

life was threatened by coward Assistant U.S. Attorney Billy Lee Barnett. Mr.

Vines has the evidence pertaining to Ada Jones "Last Will and Testament" that was on record with the Jefferson County Probate Court. Mr. Vines wrote two individuals which was Assistant U.S. Attorney Billy Lee Barnett and Probate Judge O.H. Florence, who was sending money from the Estate of Ada Jones to his personal bank account in 1989.

Mr. Vines has Assistant U.S. Attorney Billy Lee Barnett's signature where he had intervened on the State Murder Investigation of Ada Jones. Mr. Billy Lee Barnett used F.B.I. Drug Agent Jeffery Burgess as his muscle for a percentage of Ada Lee Mays Jones Estate. When Billy Lee Barnett contacted Mr. Vines instead of giving Mr. Vines a response when he wrote to him at the U.S. Attorneys Office for Northern Alabama, money hungry Billy Lee Barnett gave Mr. Vines a threat on his life with a \$50,000 contract if Mr. Vines exposed him on a plan to embezzle the money from the true inheritors. Mr. Barnett is a dirty-Ex Prosecutor.

Mr. Vines wrote Ex-Assistant U.S. Attorney Billy Lee Barnett to release the money to Iris and William Anthony Fagnes, money worth about \$28 Million Dollars. Ex-Assistant U.S. Attorney Billy Lee Barnett thought at first that my Ex-Attorney Randy Allen Dempsey, who was employed with the F.B.I. for about 6 months, privately tells his clients that the reason he didn't want a career with the F.B.I. was that there are so many crooked F.B.I. Agents who commits so many crimes and they're never investigated by their peers. Mr. Dempsey says this is reason for immediately resigning from the bureau.

Mr. Dempsey is Congressman Spencer T. Bachus III law partner. Mr. Bachus is very aware of the embezzling of Ada ~~Mays~~ Jones Estate by Dempsey, Barnett, Burgess, and persons known and unknown to the court. Dempsey, who is hiding reports to free me from prison, and this is on God. Mr. Mueller, I was framed by Agent jay Bartholomew, who messed up an investigation on 9/7/01. Mr. Dempsey stated to me, if Central Headquarters for the F.B.I. knew that Agent Bartholomew would state that he put 34 kilos of suspected cocaine in an informant's hand he didn't know and let him drive around with it in a vehicle and let it out of his eye sight for "one second", the agent would be immediately fired. Mr. Dempsey states to me, they framed you. There was never no 34 kilos. The drugs was left in Georgia on 9/7/01.

Mr. Mueller, I sent you a March 9, 2007 Motion, sent to the court for Judge C. Lynwood Smith Jr. to release a so called agreement. The Government and Attorney Randy Allen Dempsey don't have a signature for the fraudulent plea agreement.

In this March 9, 2007 motion, it will let you know why I'm corresponding with you for justice. Mr. Mueller, I have sent to you in a chronological order, my documents which is the truth before God, which is starting with my 2255 Memorandum Recusal for Magistrate Terry Michael C. Putnam's Response to the Government Argument, and different motions in a chronological order. As you notice that I have made my accusations under penalty of perjury and dared the dirty corrupt officials I have told the truth on, to sign declarations, Affidavits, depositions to contest my accusations. They have not, because it would be Obstruction of Justice on their behalf.

The culprits involved with framing me and holding me in prison on a Manufactured Fraudulent Indictment Scheme, which the Executive U.S. Attorneys Office Assistant Director Ms. Maria A. O'Rourke has personally signed and revealed there are no records in no U.S. Attorneys Office in the United States, or their Commonwealths on 9/26/01, charging a William Anthony Fagnes with "any attempt to possess any drugs", which is (Exhibit E) in my 2255 Memorandum. I'm being held in false imprisonment by the same corrupt officials behind hiding my aunt Ada Jones murder to steal her wealth over \$35 Million Dollars in 1988, worth today well over \$100 Million Dollars.

The dirty officials are afraid for their actions as you will see in the documents I have provided to you, Mr. Mueller. Ada Jones was fatally poisoned with an overdose of heart medication and "cocaine", to induce a heart attack. She was murdered in a scheme to make it appear she died of a heart attack in her sleep, which immediately back fired on the culprits involved with killing her to make it appear she died of a heart attack in her sleep. As you will see the evidence in the documents which is irrefutable.

Mr. Mueller, I have made allegations against F.B.I. Agent Jeffery Burgess, which, Mr. Mueller, you told Senator Arlen Specter, at a recent Senate Judiciary Hearing pertaining to allegations being ignored by citizens making complaints concerning corrupt officials, which you told Senator Arlen Specter

that "perhaps" if your office don't investigate matters such as a big magnitude, "perhaps" the district that the corrupt officials is from will never investigate the charges, and you state, Mr. Mueller, that the F.B.I.'s new main objective is to vigorously investigate public corruption. You don't care what level or who they are. I believe you was sincere, Mr. Mueller.

Now, Mr. Mueller, have your investigators in Washington, D.C., not locally in Birmingham, to call

Army Airborne, in Birmingham, Alabama, he has the evidence which is irrefutable pertaining to Ada Lee Mays Jones Estate. He has Ex-assistant U.S. Attorney dirty-Billy Lee Barnett freezing Ada Jones Estate in 1989, taking over a Murder Investigation pertaining to the Government interceding on a State Murder Investigation of the heinous murder of Ada Lee Mays Jones on 11/14/88.

Mr. Gerald Vines life has been threatened by this punk, Billy Lee Barnett with a \$50,000 Dollar contract if he ever expose him embezzling the Estate of Ada Jones, worth over \$35 Million Dollars in 1988, which is in the hands of U.S. Congressman Spencer T. Bachus III Law Firm, who is embezzling the Estate using false misrepresentation by dirty-Attorney Randy Allen Dempsey and crooked bankers. It's an ongoing crime where the "Last Will and Testament" of Ada Jones has been hidden from the true inheritors, the Fagnes Family, and the conspirators involved is the reason I was framed with perjury and they used a many F.B.I. Agents over the years to investigate me and get me out the way, but the agents never knew their dark heinous secrets.

And Also, could your office send my complete portfolio to Attorney General Alberto Gonzales office at the Executive U.S. Attorneys office in Washington, D.C., and also send Senator Arlen Specter my complete portfolio and make their office aware of the wrongdoing by these corrupt officials in Alabama who think

they're "above the law" because they're being protected by bribe taking judges, and U.S. Attorney Alice H. Martin been known the culprits committed the crime against the Estate of Ada Jones, but chose to turn a blind eye.

Mr. Mueller, immediately call Captain Robert Ellis at 606-928-6414 Ext. 315. He is employed with Ashland F.C.I. and can tell you what the Justice Department Investigator relayed to him that my whole story is the truth from their investigation in 2003, so forth U.S. Attorney Alice H. Martin has not brought charges against the corrupt officials because of the embarrassment to her office. The SCLC and different organizations is aware of Ada Jones death being a cover up and know that her mother, Anna Wilson Harrell, was the richest black person for years on in the State of Alabama and is calling for the media to come forward with the truthful story.

I hope and pray, Mr. Mueller, that you do not turn a blind eye for partianship, co-workers you work , or etc. You being chosen, Mr. Mueller by Congress and the American people as the head Law Enforcement Agent of the United States, for your office, the F.B.I. is to let the black community and citizens of the United States know that "no one is above the law", and that wrong is wrong, and this is the case to bring popularity back to the officials in Washington, D.C., who has been chosen to uphold the law and not conspire to conceal a citizen. death to steal her wealth, who would want to protect such evil by corrupt money hungry officials using the Government as a sheild to violate the law.

I will wait to immediately and expeditiously hear from your office, informing me that you turned over my documents to the above mentioned officials, and there will definitely be an investigation. One call will easily solve the crime and the truth will be revealed.
