**Subject:** This is a formal request under the State of Alabama Open Records Act Pursuant to Alabama Code § 36-12-40

**Re:** Records Request for Ms. Ada Mays Jones Murder Investigation

Dear Deputy City Attorney Thomas Bentley,

The family of the late Ms. Ada Lee Mays Jones born December 23, 1919 with a social security number: 416-14-7012 residence 1124-24<sup>th</sup> Avenue North Birmingham, Alabama is requesting documentation that is a matter of public record. My name is Mr. William A. Fagnes and I am the nephew of Mrs. Jones (from Here-on). I personally came to City Hall on October 29, 2015 and placed into the hands of officials employed by the City of Birmingham Law Department the same request (attached hereto) respectfully requesting to the City of Birmingham to release the murder investigation records. These records should show the investigation findings that were conducted by the Birmingham Homicide Division starting on approximately November 16, 1988 pertaining to foul play involving the death of Mrs. Jones the most affluent citizen in the City of Birmingham as stated by Former Mayor of Birmingham "Richard Arrington" after the death of Mrs. Jones.

Corrupt, Local Government Officials who took a suborn from the original architects devised the evil scheme to fatally poison Mrs. Jones and make it appear that she died of natural causes which subsequently backfired on the willing participants involved in the heinous crime to benefit from Mrs. Jones 40+ million dollar estate. Her final will and testament was hid from record at the Jefferson County Probate Court. The Jefferson County Coroner's Office would notify the Birmingham Homicide Division, which was then headed by Captain Robert Walker that foul play was involved in the death of Mrs. Jones. The Birmingham Homicide Division would later start the murder investigation of Mrs. Jones whose niece; Ms. Gwendolyn Hardy Davis would become the primary suspect into her aunt's death due to the inconsistencies that Gwendolyn Davis gave to the Birmingham Fire & Rescue Squad who was dispatched to Mrs. Jones residence on the early morning of November 16, 1988.

The Birmingham Fire and rescue squad would make the determination that Mrs. Jones was dead and was pronounced dead at 6:37a.m. Birmingham Police Department Officer Richard Landers was dispatched to Mrs. Jones residence from the North Birmingham Police Precinct, and relayed the information that was received from Mrs. Jones's niece, Gwendolyn Davis that Mrs. Jones was alive and alert 51 minutes earlier. It was stated that she had been a patient approximately 8 hours earlier at Carraway Hospital as seen attached hereto in the particulars surrounding death (see back of page) Mrs. Jones was alleged, by Gwendolyn Davis, to have eaten crackers and chicken noodle soup prior to her being pronounced dead. When she was pronounced dead, Mrs. Jones had a Carraway Hospital band on her arm stating that she had been a patient at Carraway Hospital 8 hours earlier. She was attended to by Doctor Hoyt Price who alleged to have prescribed (2) medicine prescriptions for Mrs. Jones as seen (attached hereto) in the Particulars surrounding Death (File No: 88-1771).

This misconduct stating that Mrs. Jones was a patient at Carraway Hospital was staged by the murder conspirators. Deputy Corner, Jack R. Parker who was given the flimsy story by Birmingham Police Officer Richard Landers where both was dispatched to Mrs. Jones's residence when she was pronounced dead.

Coroner Jack R. Parker knew from his expertise 36-48 hours due to rigamortis that had set up in her body, and that there was no way that Mrs. Jones was alive and alert 51 minutes earlier before being pronounced dead, he knew also that Mrs. Jones could not have been a patient 8 hours earlier at Carraway Hospital, alleged to have been an emergency room patient that was attended to by a Dr. Hoyt Price who was located in the year of 2011. Dr. Hoyt Brown Price II admitted as an emergency room doctor at Carraway Hospital and he never prescribed any patient any Vistaril or Phenergan and to much surprise he asked what was Vistaril and Phenergan.

The Birmingham Homicide Division started a vigorous and immediate investigation into foul play involving Mrs. Jones's death and Gwendolyn Davis became the primary suspect. The murder conspirators such as the trustee of Mrs. Jones's "Last Will and Testament", dirty attorney Mary Lee Abele and Iris Elaine Hardy McNabb who was the mastermind and sister of Gwendolyn Davis who was mad with Mrs. Jones for disinheriting them from her new "Final Will" which became the motive for Mrs. Jones's heinous murder conspiracy.

The City of Birmingham and Jefferson County District Attorney's Office would turn over the investigation to local dirty government officials, which was a dirty ploy to give Mrs. Jones murder conspirators a pass for her murder so that they could benefit financially from Mrs. Jones's 45 million dollar estate which had been frozen by the Jefferson County District Attorney's Office. The family of Mrs. Jones has been given the run-around by the City of Birmingham when respectfully seeking the records that your office maintains. As it is, it is an obligation of the City of Birmingham pursuant to the State of Alabama open records act. The family of Mrs. Jones would respectfully request to the City of Birmingham to disassociate the City of Birmingham character from this injustice before the heinous crime goes public to the world and the City of Birmingham would definitely be named as a conspirator of the murder cover up by not releasing the murder investigation records by the City of Birmingham Homicide Division. "No one is above or below the Law"

Because there is an exceptional need and urgency for the information documents and reports sought, the requestor ask that this open records request be given priority and expeditious consideration. Disclosure of the requesting information, documents and records to me is in the interest of the family of Mrs. Ada Lee Mays Jones, as it is likely to contribute to the clarification of constitutional and/or legal issues. I have supplied to your office documents concerning Mrs. Jones death.

6. 2 Birmingham Times Newspaper Editorials dated: June 12, 2008 and July 16, 2009 that reveals the murder cover-up of Mrs. Jones, the dirty officials refused to respond due to their guilt
7. State of Alabama Certificate of Death For Gwendolyn Hardy Davis File NO: 09-08033, she was one of the murder conspirators and also the person who gave fraudulent information to the Birmingham Fire and Rescue Squad, Officer Landers and Jefferson County Deputy Coroner Jack R. Parker.
